FISCAL ANALYSIS

ASSUMPTION

Officials at the **Office of the Secretary of State**, the **Department of Economic Development** and the **Department of Natural Resources** each assume no fiscal impact to their respective agencies from this proposal.

Officials at the St. Louis County Board of Election Commission, the Jackson County Board of Election Commission, the Platte County Board of Election Commission, the Callaway County Commission, the City of Kansas City, the City of Columbia and the Metropolitan St. Louis Sewer District each assume no fiscal impact to their respective entities from this proposal.

Oversight assumes the proposed legislation establishes procedures for the sale of municipally-owned water or sewer systems. The proposal states "If a municipally-owned water or sewer system serves less than fifty percent of the city's population, no voter ratification is required for sale of the system". Oversight assumes this section of the proposal could create a savings to local political subdivisions by not having to go through the voting process. However, Oversight is unclear on the number of systems this proposal would affect. Therefore, Oversight will assume a minimal amount would be affected and show a \$0 fiscal impact for the proposal.
