FISCAL ANALYSIS

ASSUMPTION

Officials at the **Office of the Secretary of State (SOS)** assume this proposal subjects all proportional costs of elections that would be paid by the state under Sections 115.063 or 115.065, RSMo, to the legislative appropriations process. Depending on the need for special elections and the level of future appropriations by the General Assembly, the Elections Division anticipates fiscal savings of \$0 to \$400,000 in years without a presidential election (FY 2018 and FY 2019) and \$0 to \$7,776,574 in presidential election years (FY 2020). Savings may exceed these numbers in years where the demand for special elections is higher than usual.

Oversight will round SOS' estimate to \$7.8 million in presidential election years.

Officials at the **Platte County Board of Elections** state the cost of a countywide election in Platte County is approximately \$75,000 per special election.

Officials at the **Kansas City Election Board** assume the fiscal impact of this proposal could be substantial on small entities such as school districts, if they are forced to pick up the state's share of election costs. If no appropriations are made, they could be forced to pay thousands more than is normally budgeted.

Officials at Buchanan County assume this proposal will have a fiscal impact; however; it depends on whether the state is given appropriations for election costs.

Oversight assumes there will be a negative fiscal impact to local election authorities if election costs are not appropriated and not reimbursed; therefore, Oversight will reflect a cost to local election authorities equal to the potential state savings estimated by SOS.

Officials at the following boards of election commission: St. Louis City Board of Election Commission, Clay County Board of Election Commission, Jackson County Board of Election Commission and St. Louis County Board of Election Commission did not respond to **Oversight's** request for fiscal impact.

Officials at the following counties: Andrew, Atchison, Boone, Camden, Carroll, Christian, Clay, Cole, Cooper, Daviess, Franklin, Knox, Marion, Miller, Montgomery, New Madrid, Phelps, Platte, and Wayne did not respond to **Oversight's** request for fiscal impact.
