FISCAL ANALYSIS

ASSUMPTION

Officials at the **Office of the Secretary of State (SOS)** assume this proposal removes Section 115.063.3 from law, which states that "[t]he state shall not be liable for any costs of a general election or primary election held in even numbered years as designated in subsections 1 and 2 of section 115.121." The removal of this section could create the obligation for the state to pay its share of costs for the regularly-scheduled primary and general elections, as established in Section 115.077.

Since the state's liability to pay costs for primary and general elections was previously waived by Section 115.063.3, it will be difficult to determine the exact costs which will be incurred in paying for those two elections in each election cycle. For the 2016 Presidential Preference Primary election, the most recent statewide election for which costs were paid, the state expended funds in excess of \$7.8 million. While costs for the primary and general elections may either be greater (due to increased scope) or less (due to cost sharing by local political subdivisions) than this amount, we expect that the costs per election could be (and could exceed) 50% to 75% of the \$7.8 million.

Accounting for both the primary and general elections in each election cycle, the Elections Division anticipates costs of approximately \$7.8 million to \$11.7 million in each odd-numbered fiscal year beginning in FY 2019.

Officials at the **St. Louis County Board of Election Commission** assume this proposal will have a positive impact of approximately \$1,000,000 in even-year election cycles.

Officials at the **Platte County Board of Elections** assume this proposal will not have a direct fiscal impact; however, proportional cost sharing with the state could save up to \$45,000 per election.

Officials at the **Kansas City Election Board** assume it will cost the state approximately \$600,000 in election costs every even-numbered year.

Officials at **Buchanan County** assume this proposal will benefit their organization if the state helps to pay costs for holding primary and general elections.

Oversight assumes there will be a positive fiscal impact to local election authorities if election costs are paid by the state in even-numbered years; therefore, Oversight will reflect a savings to local election authorities equal to the potential costs estimated by SOS.
