FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Health and Senior Services - Division of Regulation and Licensure (DHSS)** would require services from Information Technology Services Division to modify an existing application (MOHWORX) to support the addition of the "assistant physician" to the mid-level practitioner application with the corresponding standards questions and create a new type of registration for this category.

DHSS assumes a one time cost of \$71,280 in FY 2018 to provide for the implementation of the changes in this proposal.

Officials from the **Department of Insurance**, **Financial Institutions and Professional Registration**, the **Department of Social Services** and the **Department of Mental Health** each assume the proposal will have no fiscal impact on their respective organizations.

FISCAL DESCRIPTION

This bill requires any medical school graduate who has met the requirements to be an assistant physician as of August 28, 2014 and who applies for licensure as of the effective date of the bill to be deemed in compliance with the provisions of the bill.

This bill has an emergency clause.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
