FISCAL ANALYSIS

ASSUMPTION

In response to a previous version of this proposal, officials from the **University of Missouri Health Care (UMHC)** stated they had reviewed the proposed legislation and determined that the fiscal impact should not exceed \$100,000 annually.

Oversight assumes the costs incurred by the UMHC related to this proposal can be absorbed within current resource levels.

Officials from the **Department of Health and Senior Services**, the **Department of Mental Health**, the **Department of Social Services**, the **Office of State Courts Administrator** and the **Columbia/Boone County Department of Public Health and Human Services** each assume the proposal would not fiscally impact their respective agencies.
