FISCAL ANALYSIS

ASSUMPTION

Cole County cannot estimate the hours at this time and there will be an on going cost.

In response to a previous version, officials at the **Callaway County Commission** assumed there will be some impact on payroll for personnel entering data.

Officials at the **City of Kansas City** assume this proposal may have a negative fiscal impact on the City by requiring additional staff time to provide the additional information required by this proposal.

In response to a previous version, officials at the **City of Fulton** assumed an annual cost of \$2,000.

Officials at the **Office of Administration's Information Technology Services Division**, the **Office of State Auditor** and the **State Tax Commission** each assume no fiscal impact to their respective agencies from this proposal.

Officials at St. Louis County assume no fiscal impact from this proposal.

FISCAL IMPACT - Small Business

FISCAL DESCRIPTION

This bill specifies that every county or municipality who's annual budget is less than \$500,000 must establish and operate its own government website that is available to members of the public and update the website each month. The Office of Administration shall make a template available to counties and municipalities and outside entities may be hired to run and maintain the website. The required information that the website must contain is specified in the bill.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
