FISCAL ANALYSIS

ASSUMPTION

Officials at **Cole County** assume this proposal imposes potential additional duties on the County Collector and the County Commission, which will not only involve extra work in those offices, but also adds legal action participation by the Commission or Collector. No means of compensation for these additional duties has been provided by the legislation, including costs of a legal action. The additional costs cannot be determined at this time, but are estimated to be less than \$100,000 per year.

Officials at the **St. Charles County Collector of Revenue** assumes a cost in the tens of thousands of dollars for this proposal.

Oversight assumes the potential costs of additional duties from this legislation can be absorbed within current budget appropriations.

In response to a previous version, officials at **Boone County** assumed \$25,000 in resources dedicated annually to review litigation from this legislation.

Oversight assumes litigation expenses from this legislation are an indirect expense and will reflect no direct fiscal impact from this proposal.

Officials at the **Office of the State Courts Administrator**, the **State Tax Commission**, the **Department of Revenue**, the **Office of the State Public Defender** and the **Office of Prosecution Services** each assume no fiscal impact to their respective agencies from this proposal.

In response to a previous version, officials at **St. Louis County** assumed no fiscal impact from this proposal.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
