FISCAL ANALYSIS

ASSUMPTION

Officials at the **Department of Revenue (DOR)** assume no fiscal impact from this proposal.

Officials at **St. Louis County** and the **Cole County Recorder of Deeds** each assume no fiscal impact to their respective entities from this proposal.

Using information from the DOR's Fees Administered Report fiscal year ending June 30, 2016, **Oversight** assumes the following information:

A \$1 increase from this proposal would result in additional revenues of greater than \$4,000,000 each year. However, Oversight is unclear in the legislation on how the additional \$1 increase would be distributed (either to the Statutory County Recorder's Fund or to the Collecting Counties). According to the fiscal description of the proposal, the additional \$1 fee will go to the Statutory County Recorder's Fund (0251). However, according to annual fund activity reports from the Office of the State Treasurer, there has been no activity in the state's Statutory County Recorder's Fund over the past two years and there is no balance in the fund. Therefore, Oversight will reflect a fiscal impact greater than \$4,000,000 to the counties for this proposal. Oversight will reflect 10 months of impact in FY 2018.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION

This bill increases from \$5 to \$6 a fee that is charged and collected by the county recorder on each instrument recorded. The extra \$1 will increase from \$2 to \$3 the part of the fee that is distributed to the statutory county recorder's fund. The bill also provides a method by which distributions from the fund will be allocated among counties if collections fall below distributions.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
