#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials at the **Department of Elementary and Secondary Education** assume there is no fiscal impact from this proposal.

Officials at the **Bakersfield R-IV School District** assume a cost of \$10,000 to \$21,000 annually.

Officials at the **Kirksville R-III School District** assume this would have a negative impact.

Officials at the **Milan C-2 School District** assume the negative impact could be high.

Officials at the **Kansas City** and the **Seymour R-II** school districts each assume there is no fiscal impact from this proposal to their respective district.

**Oversight** notes this proposal would allow a student that is home schooled to participate in any extracurricular activity offered by their school district in the same manner provided enrolled students. Oversight notes that the home school student would be responsible for the same policies regarding registration, eligibility, fees, insurance, transportation, physical condition qualifications and responsibilities as enrolled students.

**Oversight** notes that many of the extracurricular activities offered by school districts limit the number of students that can participate (example- students on a sports team). This proposal would expand those eligible to try out but not increase the number that could participate. Therefore, the school districts would not incur any additional expenses in those situations.

**Oversight** notes that in extracurricular activities that do not limit the number of students that can participate (such as band, choir or robotics) there are often fees associated with joining or travel. Oversight assumes that in any extracurricular activity that assesses a fee the additional costs would be offset and the impact to the district would be zero.

#### FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

#### FISCAL DESCRIPTION

This bill requires schools and school districts to provide home school students with the same opportunity to participate in extracurricular activities as students enrolled in public schools. Home school students will be eligible to participate in activities for the school in whose attendance area the student resides. Home school students are subject to the same policies as students enrolled in the public school, in addition to the academic and attendance requirements required of students receiving home instruction.

No school or school district may impose additional rules or fees on participating home school students that differ or exceed those imposed on other students participating in the same activity.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
