**AN ACT**

To repeal sections 174.709, 174.712, and 178.862, RSMo, and to enact in lieu thereof three new sections relating to community college police officers.

---

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Sections 174.709, 174.712, and 178.862, RSMo, are repealed and three new  
2 sections enacted in lieu thereof, to be known as sections 174.709, 174.712, and 178.862, to read  
3 as follows:

174.709. 1. For the purpose of promoting public safety, health, and general welfare and  
2 to protect life and property, the board of regents or board of governors of any state college or  
3 university **or the board of trustees of any community college district** may establish  
4 regulations to control vehicular traffic, including speed regulations, on any thoroughfare owned  
5 or maintained by the state college or university **or community college district** and located  
6 within any of its campuses. Such regulations shall be consistent with the provisions of the  
7 general motor vehicle laws of this state. Upon adoption of such regulations, the state college or  
8 university **or community college** shall have the authority to place official traffic control signals,  
9 as defined in section 300.010, on campus property.

10 2. The regulations established by the board of regents or board of governors of any state  
11 college or university **or board of trustees of any community college district** under subsection  
12 1 of this section shall be codified, printed, and distributed for public use. Adequate signs  
13 displaying the speed limit shall be posted along such thoroughfares.

14 3. Violations of any regulation established under this section shall have the same effect  
15 as a violation of municipal ordinances adopted under section 304.120, with penalty provisions  
16 as provided in section 304.570. Points assessed against any person under section 302.302 for

17 a violation of this section shall be the same as provided for a violation of a county or municipal  
18 ordinance.

19 4. The provisions of this section shall apply only to moving violations.

174.712. All motor vehicles operated upon any thoroughfare owned or maintained by  
2 a state college or university **or community college district** and located within any of its  
3 campuses shall be subject to the provisions of the general motor vehicle laws of this state,  
4 including chapters 301, 302, 303, 304, 307, and 577. Violations shall have the same effect as  
5 though such had occurred on public roads, streets, or highways of this state.

178.862. 1. The trustees of any community college district of this state may appoint and  
2 employ as many college police officers as they may deem necessary to protect persons, property,  
3 and to preserve peace and good order only in the public buildings, properties, grounds, and other  
4 facilities and locations over which they have charge or control.

5 2. The college police officers, before they enter upon their duties, shall take and  
6 subscribe an oath of office before some officer authorized to administer oaths, to faithfully and  
7 impartially discharge the duties thereof, which oath shall be filed in the office of the college  
8 district board of trustees, and the secretary of the board shall give each college police officer so  
9 appointed and qualified a certificate of appointment, under the seal of the board of trustees,  
10 which certificate shall empower him with the same authority to maintain order, preserve peace  
11 and make arrests as is now held by peace officers; the college police officer may in addition  
12 expel from the public buildings, campuses, and grounds, persons violating the rules and  
13 regulations that may be prescribed by the board of trustees or others under the authority of the  
14 board. Such officer or employee of the community college as may be designated by the board  
15 of trustees shall have immediate charge, control and supervision of college police officers  
16 appointed by authority of this section. Such college police officers shall have satisfactorily  
17 completed before appointment~~[, or within six months after appointment,]~~ a training course for  
18 ~~[college police]~~ **peace** officers ~~[which shall consist of at least three hundred twenty hours as~~  
19 ~~prescribed by the superintendent of the Missouri state highway patrol. The community college~~  
20 ~~district shall reimburse all such college police officers appointed by them who complete the~~  
21 ~~training course for all reasonable and necessary expenses incurred in taking the training course,~~  
22 ~~and shall reimburse the highway patrol for any expenses directly relating to the prescribed or~~  
23 ~~holding of a training course which are recommended by the patrol]~~ **as required under chapter**  
24 **590 or, by virtue of previous experience or other training, shall have met the requirements**  
25 **of chapter 590.**

26 3. Nothing herein shall be construed as denying the board of trustees the right to appoint  
27 guards or watchmen who shall not be given the authority and powers hereby authorized.
