## AN ACT

To repeal section 160.518, RSMo, and to enact in lieu thereof one new section relating to statewide assessments.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 160.518, RSMo, is repealed and one new section enacted in lieu 2 thereof, to be known as section 160.518, to read as follows:

160.518. 1. (1) Consistent with the provisions contained in section 160.526, the state board of education shall develop, modify, and revise, as necessary, a statewide assessment 2 system that provides maximum flexibility for local school districts to determine the degree to 3 which students in the public schools of the state are proficient in the knowledge, skills, and 4 competencies adopted by such board pursuant to section 160.514. The statewide assessment 5 system shall assess problem solving, analytical ability, evaluation, creativity, and application 6 ability in the different content areas and shall be performance-based to identify what students 7 8 know, as well as what they are able to do, and shall enable teachers to evaluate actual academic 9 The statewide assessment system shall neither promote nor prohibit rote performance. 10 memorization and shall not include existing versions of tests approved for use pursuant to the provisions of section 160.257, nor enhanced versions of such tests. After the state board of 11 12 education adopts and implements academic performance standards as required under section 161.855, the state board of education shall develop and adopt a standardized assessment 13 14 instrument under this section based on the academic performance standards adopted under section 161.855. The statewide assessment system shall measure, where appropriate by grade 15 16 level, a student's knowledge of academic subjects including, but not limited to, reading skills,

writing skills, mathematics skills, world and American history, forms of government, geographyand science.

19 (2) Notwithstanding subdivision (1) of this subsection, the state board of education 20 shall not make any substantive change to any assessment test developed in accordance with 21 this section or eliminate its administration until schools have administered the test to 22 students for five consecutive school years, unless revision or elimination of the test is 23 required in order to comply with federal law.

24 2. The statewide assessment system shall only permit the academic performance of 25 students in each school in the state to be tracked against prior academic performance in the same 26 school.

27 3. The state board of education shall suggest, but not mandate, criteria for a school to 28 demonstrate that its students learn the knowledge, skills and competencies at exemplary levels 29 worthy of imitation by students in other schools in the state and nation. Exemplary levels shall 30 be measured by the statewide assessment system developed pursuant to subsection 1 of this 31 section, or until said statewide assessment system is available, by indicators approved for such 32 use by the state board of education. The provisions of other law to the contrary notwithstanding, 33 the commissioner of education may, upon request of the school district, present a plan for the 34 waiver of rules and regulations to any such school, to be known as "Outstanding Schools 35 Waivers", consistent with the provisions of subsection 4 of this section.

36 4. For any school that meets the criteria established by the state board of education for 37 three successive school years pursuant to the provisions of subsection 3 of this section, by 38 August first following the third such school year, the commissioner of education shall present 39 a plan to the superintendent of the school district in which such school is located for the waiver 40 of rules and regulations to promote flexibility in the operations of the school and to enhance and 41 encourage efficiency in the delivery of instructional services. The provisions of other law to the 42 contrary notwithstanding, the plan presented to the superintendent shall provide a summary waiver, with no conditions, for the pupil testing requirements pursuant to section 160.257[,] in 43 44 the school. Further, the provisions of other law to the contrary notwithstanding, the plan shall 45 detail a means for the waiver of requirements otherwise imposed on the school related to the 46 authority of the state board of education to classify school districts pursuant to subdivision (9) 47 of section 161.092 and such other rules and regulations as determined by the commissioner of 48 education, excepting such waivers shall be confined to the school and not other schools in the 49 district unless such other schools meet the criteria established by the state board of education 50 consistent with subsection 3 of this section and the waivers shall not include the requirements 51 contained in this section and section 160.514. Any waiver provided to any school as outlined 52 in this subsection shall be void on June thirtieth of any school year in which the school fails to

53 meet the criteria established by the state board of education consistent with subsection 3 of this 54 section.

55 5. The score on any assessment test developed pursuant to this section or this chapter of 56 any student for whom English is a second language shall not be counted until such time as such 57 student has been educated for three full school years in a school in this state, or in any other state, 58 in which English is the primary language.

59 6. The state board of education shall identify or, if necessary, establish one or more 60 developmentally appropriate alternate assessments for students who receive special educational 61 services, as that term is defined pursuant to section 162.675. In the development of such 62 alternate assessments, the state board shall establish an advisory panel consisting of a majority 63 of active special education teachers residing in Missouri and other education professionals as 64 appropriate to research available assessment options. The advisory panel shall attempt to 65 identify preexisting developmentally appropriate alternate assessments but shall, if necessary, 66 develop alternate assessments and recommend one or more alternate assessments for adoption 67 by the state board. The state board shall consider the recommendations of the advisory council in establishing such alternate assessment or assessments. Any student who receives special 68 69 educational services, as that term is defined pursuant to section 162.675, shall be assessed by an 70 alternate assessment established pursuant to this subsection upon a determination by the student's 71 individualized education program team that such alternate assessment is more appropriate to 72 assess the student's knowledge, skills and competencies than the assessment developed pursuant 73 to subsection 1 of this section. The alternate assessment shall evaluate the student's independent 74 living skills, which include how effectively the student addresses common life demands and how 75 well the student meets standards for personal independence expected for someone in the student's 76 age group, sociocultural background, and community setting.

77 7. The state board of education shall also develop recommendations regarding alternate 78 assessments for any military dependent who relocates to Missouri after the commencement of 79 a school term, in order to accommodate such student while ensuring that he or she is proficient 80 in the knowledge, skills, and competencies adopted under section 160.514.
