

# House Concurrent Resolution No. 22

## 99TH GENERAL ASSEMBLY

INTRODUCED BY REPRESENTATIVE SHAUL (113).

2           **WHEREAS**, steamboats are deeply entwined in Missouri's history and culture; and

3

4           **WHEREAS**, the Delta Queen steamboat operated for many years and in many areas  
5 across the country as top-of-the-line luxury travel, and was previously allowed to provide  
6 overnight cruises; and

7

8           **WHEREAS**, the Delta Queen steamboat has carried three different United States  
9 Presidents, and transported delegates of 51 other nations during the founding conference of the  
10 United Nations; and

11

12           **WHEREAS**, the Delta Queen is widely considered the last steamboat of its kind with  
13 overnight guest rooms; and

14

15           **WHEREAS**, the Delta Queen was once home to Mary Greene, who was one of the first  
16 women to become a licensed river pilot; and

17

18           **WHEREAS**, the Delta Queen is expected to visit over 80 different ports in the United  
19 States when it resumes operation; and

20

21           **WHEREAS**, the Delta Queen has established a home port, restaurant, and headquarters  
22 in Kimmswick, Missouri; and

23

24           **WHEREAS**, the Delta Queen Steamboat Co. has created over 170 local jobs and is  
25 expected to bring in more than \$36.4 million to the region annually; and

27           **WHEREAS**, resuming overnight cruises would bring even more economic benefits to  
28 the region, and create further economic growth and opportunity; and

29

30           **WHEREAS**, the Delta Queen has been designated as a "National Treasure" by the  
31 National Trust for Historic Preservation, listed on the National Register of Historic Places, and  
32 declared a National Historic Landmark; and

34           **WHEREAS**, the Delta Queen was named to the National Trust for Historic  
35 Preservation's "11 most endangered list" for 2016; and

37           **WHEREAS**, United States Senate Bill S. 89 exempts old vessels that only operate within  
38 the inland waterways from federal fire-retardant materials requirements if the owners of the  
39 vessel make annual structural alterations to at least ten percent of the areas of the vessel that are  
40 not constructed of fire-retardant materials:

42           **NOW THEREFORE BE IT RESOLVED** that the members of the House of  
43 Representatives of the Ninety-ninth General Assembly, First Regular Session, the Senate  
44 concurring therein, hereby urge that the United States Congress enact United States Senate Bill  
45 S. 89; and

47           **BE IT FURTHER RESOLVED** that the Chief Clerk of the Missouri House of  
48 Representatives be instructed to prepare a properly inscribed copy of this resolution for each  
49 member of the Missouri congressional delegation.
