HB 800 -- SALES TAX ON MANUFACTURED HOMES

SPONSOR: Crawford

This bill specifies that 40% of the retail sale or manufacturer's sale price of a new manufactured home plus any carrier charge or freight charge is considered a service and exempt from sales tax, and 60% is considered the retail sale price of tangible personal property subject to sales tax.
