AMEND House Committee Substitute for House Bill No. 1444, Pages 1-4, Section 301.020, Lines 1-87, by deleting all of said lines and removing all of said section from the bill; and

Further amend said bill, Pages 5-13, Sections 301.074, 301.132, 301.147, and 301.190, by removing all of said sections from the bill; and

Further amend said bill, Pages 15-17, Sections 301.443 and 301.800, by removing all of said sections from the bill; and

Further amend said bill, Page 17, Section 301.800, Line 12, by inserting immediately after all of said section and line the following:

"307.350. 1. The owner of every motor vehicle as defined in section 301.010 which is required to be registered in this state, except:

(1) Motor vehicles, for the ~~[five]~~ ten-year period following their model year of manufacture, excluding prior salvage vehicles immediately following a rebuilding process and vehicles subject to the provisions of section 307.380;

(2) Those motor vehicles ~~[which are engaged in interstate commerce and are proportionately registered in this state with the Missouri highway reciprocity commission, although the owner may request that such vehicle be inspected by an official inspection station, and a peace officer may stop and inspect such vehicles to determine whether the mechanical condition is in compliance with the safety regulations established by the United States Department of Transportation; and~~

~~——— (3) Historic motor vehicles registered pursuant to section 301.131;~~

~~——— (4) Vehicles registered in excess of twenty-four thousand pounds for a period of less than twelve months;]~~ with an odometer reading of no more than one hundred thousand miles;

shall submit such vehicles to a biennial inspection of their mechanism and equipment in accordance with the provisions of sections 307.350 to 307.390 and obtain a certificate of inspection and approval and a sticker, seal, or other device from a duly authorized official inspection station. The inspection, except the inspection of school buses which shall be made at the time provided in section 307.375, shall be made at the time prescribed in the rules and regulations issued by the superintendent of the Missouri state highway patrol; but the inspection of a vehicle shall not be made more than sixty days prior to the date of application for registration or within sixty days of when a vehicle's registration is transferred. Any vehicle manufactured as an even-numbered model year vehicle shall be inspected and approved pursuant to the safety inspection program established

1 pursuant to sections 307.350 to 307.390 in each even-numbered calendar year and any such vehicle  
2 manufactured as an odd-numbered model year vehicle shall be inspected and approved pursuant to  
3 sections 307.350 to 307.390 in each odd-numbered year. The certificate of inspection and approval  
4 shall be a sticker, seal, or other device or combination thereof, as the superintendent of the Missouri  
5 state highway patrol prescribes by regulation and shall be displayed upon the motor vehicle or  
6 trailer as prescribed by the regulations established by him. The replacement of certificates of  
7 inspection and approval which are lost or destroyed shall be made by the superintendent of the  
8 Missouri state highway patrol under regulations prescribed by him.

9         2. For the purpose of obtaining an inspection only, it shall be lawful to operate a vehicle  
10 over the most direct route between the owner's usual place of residence and an inspection station of  
11 such owner's choice, notwithstanding the fact that the vehicle does not have a current state  
12 registration license. It shall also be lawful to operate such a vehicle from an inspection station to  
13 another place where repairs may be made and to return the vehicle to the inspection station  
14 notwithstanding the absence of a current state registration license.

15         3. No person whose motor vehicle was duly inspected and approved as provided in this  
16 section shall be required to have the same motor vehicle again inspected and approved for the sole  
17 reason that such person wishes to obtain a set of any special personalized license plates available  
18 pursuant to section 301.144 or a set of any license plates available pursuant to section 301.142, prior  
19 to the expiration date of such motor vehicle's current registration.

20         4. Notwithstanding the provisions of section 307.390, violation of this section shall be  
21 deemed an infraction."; and
