1 AMEND House Committee Substitute for Senate Bill No. 800, Page 9, Section 211.447, Line 218,
2 by inserting immediately after said section and line the following:

4 "478.600. 1. There shall be four circuit judges in the eleventh judicial circuit. These judges
5 shall sit in divisions numbered one, two, three and four. Beginning on January 1, 2007, there shall
6 be six circuit judges in the eleventh judicial circuit and these judges shall sit in divisions numbered
7 one, two, three, four, five, and seven. The division five associate circuit judge position and the
8 division seven associate circuit judge position shall become circuit judge positions beginning
9 January 1, 2007, and shall be numbered as divisions five and seven.

10 2. The circuit judge in division two shall be elected in 1980. The circuit judge in division
11 four shall be elected in 1982. The circuit judge in division one shall be elected in 1984. The circuit
12 judge in division three shall be elected in 1992. The circuit judges in divisions five and seven shall
13 be elected for a six-year term in 2006.

14 3. Beginning January 1, 2007, the family court commissioner positions in the eleventh
15 judicial circuit appointed under section 487.020 shall become associate circuit judge positions in all
16 respects and shall be designated as divisions nine and ten respectively. These positions may retain
17 the duties and responsibilities with regard to the family court. The associate circuit judges in
18 divisions nine and ten shall be elected in 2006 for full four-year terms.

19 4. Beginning on January 1, 2007, the drug court commissioner position in the eleventh
20 judicial circuit appointed under section 478.003 shall become an associate circuit judge position in
21 all respects and shall be designated as division eleven. This position retains the duties and
22 responsibilities with regard to the drug court. Such associate circuit judge shall be elected in 2006
23 for a full four-year term. This associate circuit judgeship shall not be included in the statutory
24 formula for authorizing additional associate circuit judgeships per county under section 478.320.

25 5. Beginning in fiscal year 2015, there shall be one additional associate circuit judge
26 position in the eleventh judicial circuit. The associate circuit judge shall be elected in 2016. This
27 associate circuit judgeship shall not be included in the statutory formula for authorizing additional
28 circuit judgeships per county under section 478.320. Beginning in fiscal year 2019, there shall be
29 one additional associate circuit judge position in the eleventh judicial circuit. The associate circuit
30 judge shall be elected in 2020. This associate circuit judgeship shall not be included in the statutory
31 formula for authorizing additional circuit judgeships per county under section 478.320.

32 478.625. 1. Beginning on January 1, 2003, there shall be three circuit judges in the
33 nineteenth judicial circuit consisting of the county of Cole.

34 2. One circuit judge shall be first elected in 1982. The second circuit judge shall be first
35 elected in 1984. The third circuit judge shall be first elected in 2002.
