4 "335.046. 1. An applicant for a license to practice as a registered professional nurse shall 5 submit to the board a written application on forms furnished to the applicant. The original 6 application shall contain the applicant's statements showing the applicant's education and other such 7 pertinent information as the board may require. The applicant shall be of good moral character and 8 have completed at least the high school course of study, or the equivalent thereof as determined by 9 the state board of education, and have successfully completed the basic professional curriculum in 10 an accredited or approved school of nursing and earned a professional nursing degree or diploma. Each application shall contain a statement that it is made under oath or affirmation and that its 11 12 representations are true and correct to the best knowledge and belief of the person signing same, subject to the penalties of making a false affidavit or declaration. Applicants from non-English-13 14 speaking lands shall be required to submit evidence of proficiency in the English language. The applicant must be approved by the board and shall pass an examination as required by the board. 15 16 The board may require by rule as a requirement for licensure that each applicant shall pass an oral 17 or practical examination. Upon successfully passing the examination, the board may issue to the applicant a license to practice nursing as a registered professional nurse. The applicant for a license 18 19 to practice registered professional nursing shall pay a license fee in such amount as set by the board. 20 The fee shall be uniform for all applicants. Applicants from foreign countries shall be licensed as 21 prescribed by rule.

22 2. An applicant for license to practice as a licensed practical nurse shall submit to the board a written application on forms furnished to the applicant. The original application shall contain the 23 24 applicant's statements showing the applicant's education and other such pertinent information as the 25 board may require. Such applicant shall be of good moral character, and have completed at least two years of high school, or its equivalent as established by the state board of education, and have 26 successfully completed a basic prescribed curriculum in a state-accredited or approved school of 27 28 nursing, earned a nursing degree, certificate or diploma and completed a course approved by the 29 board on the role of the practical nurse. Each application shall contain a statement that it is made 30 under oath or affirmation and that its representations are true and correct to the best knowledge and 31 belief of the person signing same, subject to the penalties of making a false affidavit or declaration. 32 Applicants from non-English-speaking countries shall be required to submit evidence of their proficiency in the English language. 47	state, territory, or foreign country if the applicant meets the qualifications required of registered	
48	nurses or licensed practical nurses in this state at the time the applicant was originally licensed in the

2. Applicants from foreign countries shall be licensed as prescribed by rule.

3 3. Upon application, the board shall issue a temporary permit to an applicant pursuant to 4 subsection 1 of this section for a license as either a registered professional nurse or a licensed 5 practical nurse who has made a prima facie showing that the applicant meets all of the requirements 6 for such a license. The temporary permit shall be effective only until the board shall have had the 7 opportunity to investigate his qualifications for licensure pursuant to subsection 1 of this section and 8 to notify the applicant that his or her application for a license has been either granted or rejected. In 9 no event shall such temporary permit be in effect for more than twelve months after the date of its 10 issuance nor shall a permit be reissued to the same applicant. 17 335.056. 1. The license of every person licensed under the provisions of [sections 335.011] to 335.096] this chapter shall be renewed as provided. An application for renewal of license shall 18 19 be mailed to every person to whom a license was issued or renewed during the current licensing 20 period. The applicant shall complete the application and return it to the board by the renewal date 21 with a renewal fee in an amount to be set by the board. The fee shall be uniform for all applicants. 22 The certificates of renewal shall render the holder thereof a legal practitioner of nursing for the 23 period stated in the certificate of renewal. 34 335.076. 1. Any person who holds a license to practice professional nursing in this state 35 may use the title "Registered Professional Nurse" and the abbreviation "R.N.". No other person shall 36 use the title "Registered Professional Nurse" or the abbreviation "R.N.". No other person shall 37 assume any title or use any abbreviation or any other words, letters, signs, or devices to indicate that 38 the person using the same is a registered professional nurse.

2. Any person who holds a license to practice practical nursing in this state may use the title "Licensed Practical Nurse" and the abbreviation ["L.P.N."] "LPN". No other person shall use the title "Licensed Practical Nurse" or the abbreviation ["L.P.N."] "LPN". No other person shall assume any title or use any abbreviation or any other words, letters, signs, or devices to indicate that the person using the same is a licensed practical nurse.

3. Any person who holds a license [or recognition] to practice advanced practice nursing in this state may use the title "Advanced Practice Registered Nurse", the designations of "certified registered nurse anesthetist", "certified nurse midwife", "certified clinical nurse specialist", and "certified nurse practitioner", and the [abbreviation] abbreviations "APRN", [and any other title designations appearing on his or her license] "CRNA", "CNM", "CNS", and "NP", respectively. No other person shall use the title "Advanced Practice Registered Nurse" or the abbreviation "APRN".
 No other person shall assume any title or use any abbreviation or any other words, letters, signs, or
 devices to indicate that the person using the same is an advanced practice registered nurse.

4 4. No person shall practice or offer to practice professional nursing, practical nursing, or 5 advanced practice nursing in this state or use any title, sign, abbreviation, card, or device to indicate 6 that such person is a practicing professional nurse, practical nurse, or advanced practice nurse unless 7 he or she has been duly licensed under the provisions of this chapter.

5. In the interest of public safety and consumer awareness, it is unlawful for any person to use the title "nurse" in reference to himself or herself in any capacity, except individuals who are or have been licensed as a registered nurse, licensed practical nurse, or advanced practice registered nurse under this chapter.

6. Notwithstanding any law to the contrary, nothing in this chapter shall prohibit a Christian Science nurse from using the title "Christian Science nurse", so long as such person provides only religious nonmedical services when offering or providing such services to those who choose to rely upon healing by spiritual means alone and does not hold his or her own religious organization and does not hold himself or herself out as a registered nurse, advanced practice registered nurse, nurse practitioner, licensed practical nurse, nurse midwife, clinical nurse specialist, or nurse anesthetist, unless otherwise authorized by law to do so.
