FISCAL ANALYSIS

ASSUMPTION

Officials from the **St. Louis County Government** assume a county-wide election with only the proposed question would cost St. Louis County approximately \$1.5 million.

Officials from the **University of Central Missouri** assume should HB 1270 pass and become law, there would be monetary savings to the university. Based upon just the convenience contracts where University of Central Missouri utilizes contractors to perform work, conservatively, they estimate the savings could easily be \$200,000. This calculation is roughly based upon an average of the convenience contracts where due to the prevailing wage law, the costs are higher than they would be if the prevailing wage law was redacted.

Officials from **Missouri Western State University** assume an impact, depending upon the voters outcome of their county. A yes vote would have a positive fiscal impact to Missouri Western. A no vote would have a negative fiscal impact to Missouri Western State University.

Officials from the **State Technical College of Missouri** assume the proposal could have a positive fiscal impact.

Officials from the **Kirksville R-III School District** assume the proposal should have a positive fiscal impact on school district budgets.

Officials from the **Lathrop Schools** assume the financial savings could be significant, although cannot provide an exact amount because it would depend upon the size and scope of the project.

Officials from **Green Ridge R-8 School District** assume the proposal would have positive fiscal impact on construction projects within the school district.

Officials from **Wellsville-Middletown R-1** assume allowing public entities to be exempt from prevailing wage requirements, especially within rural communities will save a substantial amount of taxpayers' dollars and increase the ability of local vendors to successfully bid on local projects.

Officials from **Summersville R2 School District** assume the proposal would be beneficial when future construction projects proceed. With no information on number and scope of future projects, it is impossible to put a specific number to. They are converting the elementary building to wood heat (Fuels for School Grant), a project that could be \$10,000 - \$100,000 cheaper without prevailing wage requirement.

ASSUMPTION (continued)

Officials from **Macon County R-IV School District** assume there is no way to quantify savings to the district due to the nature of prevailing wage. In previous projects that required prevailing wage, it was estimated that prevailing wage, compared to local non-prevailing wages, increased labor costs from 241% (local hourly of \$12/hr compared to prevailing wage of \$29/hr) to 500% (\$60/hr compared to \$12/hr). Those costs were approximately 50% of total project costs and doubled total costs for the projects.

Officials from **West Plains Schools** assume the proposal would save capital improvement costs at about a rate of 15%. Annual savings estimated at \$100,000 - \$150,000 and up to \$3,000,000 on major projects.

Officials from **Fair Play School District** assume the proposal would make a significant difference in the coming year. The school is going to be asking for a no increase debt service levy to upgrade technology, build 2 classrooms, and re-roof two buildings. The bill would enable them to spend tax payers money more wisely by putting about \$100,000 more in the building and less on wages.

Oversight will assume a potential savings to local political subdivisions (\$0 or unknown). The savings would depend upon the results of the vote, as well as the actions of the local political subdivisions.

Officials from Office of the Secretary of State, Department of Higher Education,
Department of Labor and Industrial Relations, and Joint Committee on Legislative
Research-Office of the Revisor each assume no fiscal impact on their respective organizations.

FISCAL DESCRIPTION

This proposal allows the residents of a county to vote to exempt public subdivisions and public institutions of higher education from the prevailing wage law for the construction of public works constructed wholly within the county.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
