#### FISCAL ANALYSIS

## **ASSUMPTION**

Officials from the **Department of Insurance**, **Financial Institutions and Professional Registration** assume the proposal would not fiscally impact their agency.

Officials from the **Office of Attorney General (AGO)** assume any potential costs arising from this proposal can be absorbed with existing resources. The AGO may seek additional appropriations if the proposal results in a significant increase in litigation.

Officials from the Department of Health and Senior Services, the Department of Public Safety, Missouri State Highway Patrol, the Department of Social Services, the Missouri Consolidated Health Care Plan, the Missouri Department of Conservation, the Missouri Department of Transportation and the Office of Administration each assume the proposal would not fiscally impact their respective agencies.

**Oversight** notes "off-label" means a medication is being used in a manner not specified in the Food and Drug Administration's (FDA) approved packaging label, or insert. The FDA regulates drug approval, but not drug prescribing and doctors are free to prescribe a drug for any reason they think is medically appropriate. Pharmaceutical companies are not legally permitted to encourage or promote the use of regulated drugs for any purpose/condition not formally approved by the FDA.
