FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of Administration (OA)** assume section 536.013's requirements could generate additional state regulations causing workload increases for several Executive Branch departments. Section 536.205 could impact several departments, as over the past three years over 75 rules were identified with an estimated cost, in aggregate, over \$500,000. At this point, exact figures cannot be determined without additional analysis; however, our best estimate is that the potential impact will be less than \$400,000 annually, with a maximum of 4 additional FTE. Additional duties can be absorbed by some, but not all departments as their administrative rule workload varies. Note - federal and other funds could be impacted, but those cannot be estimated at this time.

Officials from the **Joint Committee on Administrative Rules** assume Section 536.205.5, RSMo as proposed requires the agency to send notice of the proposed rulemaking to all affected persons, firms, corporations, associations, partnerships, proprietorships, and business entities identified as likely being affected under subdivision (1) of subsection 1. Currently under subdivision (1) of subsection 1 of section 536.205 the agency only identifies such entities by classification and number and provides public notice of estimated cost by publication in the Missouri Register, so agencies likely may not have actual names and physical addresses of every entity and it is not clear how compliance and enforcement will be determined.

It is not clear that there would be any additional cost to the Joint Committee on Administrative Rules.

Officials from the **Missouri Department of Conservation** assume this proposal would have a negative fiscal impact, less than \$100,000 annually, due to cost to prepare additional fiscal note information.

Officials from the **Office of Administration - Budget and Planning (B&P)** assume this proposal requires the General Assembly to approve certain regulations through concurrent resolution. B&P assume the proposal will have no fiscal impact on their organization.

ASSUMPTION (continued)

Officials from the **Office of the Secretary of State (SOS)** assume many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the Secretary of State's Office for Administrative Rules is less than \$2,500. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, we also recognize that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what our office can sustain with our core budget. Therefore, we reserve the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

Oversight assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could request funding through the appropriation process.

Officials from the **Office of the State Auditor** assume this proposal will have no fiscal impact on their organization. Any impacts may be absorbed through current appropriations.

Officials from the **State Tax Commission**, the **Missouri State Employee's Retirement System**, the **Department of Public Safety** - **State Emergency Management Agency**, **Missouri Highway Patrol**, **Division of Alcohol and Tobacco Control**, **Missouri Veterans Commission**, **Missouri Gaming Commission**, **Capitol Police**, **Division of Fire Safety**, **Missouri National Guard**, the **Missouri Senate**, the **Missouri Lottery Commission**, the **Office of the State Treasurer**, the **MoDOT & Patrol Employees' Retirement System**, the **Office of the Governor**, the **Office of Prosecution Services**, the **Missouri Consolidated Health Care Plan**, the **Missouri House of Representatives**, the **Office of the State Courts Administrator**, the **Administrative Hearing Commission**, the **Department of Corrections**, the **Missouri Ethics Commission**, the **Office of the State Public Defender**, the **Department of Agriculture**, the **Missouri Senate**, and **Office of the Lieutenant Governor** each assume the proposal will have no fiscal impact on their respective organizations.

ASSUMPTION (continued)

Officials from the **Department of Revenue**, **Department of Economic Development**, **Department of Transportation**, **Department of Higher Education**, **Department of Public Safety (Directors Office)**, **Department of Social Services**, **Department of Elementary and Secondary Education**, **Department of Natural Resources**, **Department of Mental Health** and **Department of Insurance**, **Financial Institutions and Professional Registration** each defer to the Office of Administration to estimate the fiscal impact of the proposed legislation on their respective organization.

Officials from the **Department of Health and Senior Services** and the **Attorney General's Office** did not respond to Oversight's request for fiscal impact.

Oversight notes that most of the state agencies indicated the bill would not impact their agency, while some deferred to OA. Therefore, there appears to be a discrepancy between OA's response and most other agencies. Therefore, based on that and JCAR's response, Oversight will assume an unknown cost to various state agencies.

FISCAL DESCRIPTION

This bill requires all regulations of any type to be explicitly permitted or required by statute prior to being promulgated under Chapter 536, RSMo.

If a fiscal note estimate for a proposed rule under Chapter 536 is greater than \$500,000 in the aggregate with regard to either regulatory expenditures or estimated reductions in income, then the rule is disallowed unless approved by the General Assembly via concurrent resolution.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
