FISCAL ANALYSIS

ASSUMPTION

Section 168.021

Officials from the **Department of Elementary and Secondary Education (DESE)** assume the proposal removes reciprocity for applicants who hold a certificate in another state. It also removes fees for these applicants. DESE certifies approximately 1,500 educators from other states per year. The fee per application is \$100. The fiscal impact would lower revenue by approximately \$150,000 per year. These fees are used to maintain and enhance the online certification system which is used to certify all substitutes, teachers, counselors, administrator, etc.

Officials from the **Department of Insurance, Financial Institutions and Professional Registration**, the **Department of Revenue**, the **Department of Health and Senior Services**, the **Department of Natural Resources**, the **Department of Agriculture**, the **Department of Social Services**, the **Department of Mental Health**, the **Department of Public Safety** -**Missouri Highway Patrol** and the **Department of Transportation** each assume the proposal will have no fiscal impact on their respective organizations.

In response to a previous version, officials from the **City of Kansas City** and the **City of Columbia** each assumed the proposal will have no fiscal impact on their respective organizations.
