#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the **Department of Health and Senior Services** assume the proposal would not fiscally impact their agency.

Officials from **St. Louis County (County)** state this bill does not automatically specifically incur costs to the Department of Public Health (DPH). However, if the County chooses to add additional collection sites at the DPH clinics or where the practitioners covered by this change are located, then some minor costs for the collection tools may need to be identified.

**Oversight** notes St. Louis County describes the costs as "minor" if the County chooses to provide additional collection sites. Therefore, Oversight assumes if costs are incurred, they would be absorbable within current funding levels.

Officials from the **Department of Natural Resources**, the **Joint Committee on Administrative Rules**, the **Columbia/Boone County Department of Public Health and Senior Services**, the **City of Kansas City** and **Boone County** each assume the proposal would not fiscally impact their respective agencies.

Officials from the **Office of the Secretary of State (SOS)** state many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$2,500. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with the core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

**Oversight** assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could request funding through the appropriation process.
