FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Health and Senior Services (DHSS)** provided the response for the **Office of Administration (OA)**, **Information Technology Services Division (ITSD)/DHSS**.

OA, ITSD provides that section 188.375.5 requires the DHSS to modify the abortion reporting form to expand information currently collected on abortions. This will require modification of the existing abortion data collection tools including a Microsoft Access database for data entry of paper forms, file layouts for electronic exchange and a mainframe database used for statistical reporting. OA, ITSD estimates a one-time cost of \$6,480 for these changes.

ITSD assumes that every new IT project/system will be bid out because all ITSD resources are at full capacity. The current contract rate for IT consultants is \$75 per hour.

Oversight assumes OA, ITSD/DHSS can absorb these minimal one-time costs within current funding levels. However, Oversight notes, depending on the number of proposals passed during the legislative session that require computer system changes, that cumulatively, OA, ITSD/DHSS may need additional funding to cover the costs to complete all ITSD projects.

Officials from the **Office of Attorney General (AGO)** assume any potential costs arising from this proposal can be absorbed with existing resources. The AGO may seek additional appropriations if the proposal results in a significant increase in litigation.

Officials from the **Department of Insurance**, **Financial Institutions and Professional Registration**, the **Department of Corrections** and the **Department of Social Services**, **MO HealthNet Division** and **Division of Legal Services** each assume the proposal would not fiscally impact their respective agencies.
