ASSUMPTION

Officials at **Boone County** assume the legislation is discretionary and not mandatory. The impact could be as large as \$100,000, but could be de minimis.

Officials at **St. Louis County** assume no fiscal impact from this proposal.

Oversight assumes this proposal is permissive in nature and would have no local fiscal impact without action by the county commission. It will be up to the county commission to determine if the amount of the award is needed and is within their budgetary authority for the year. Therefore, Oversight will reflect a \$0 direct fiscal impact to Local Political Subdivisions for this proposal.
