### FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Higher Education** and the **Department of Public Safety** - **Missouri Veterans Commission** assume the proposal will have no fiscal impact on their organizations.

Officials from **Missouri State University** assume there is a negative fiscal impact in excess of \$36,000 for the university

Officials from **Missouri Western State University** assume the proposal has the potential to have a significant negative fiscal impact on the university. The negative impact is estimated at \$4,486.46 annually per eligible veteran enrolled.

Officials from the **University of Central Missouri** anticipate these changes would cost the university \$226,000 per year in tuition revenue absent any reimbursement from the State.

Officials from the **State Technical College of Missouri** assume this proposal would have no impact.

Officials from the **University of Missouri System** assume revenue could be negatively impacted by \$5.6 million to \$21.1 million annually by limiting the tuition charges and from the inability to bill and collect federal funding. This is the estimate for all UM campuses.

Officials from **Northwest Missouri State University** assume this proposal would have a negative fiscal impact to the university of approximately \$80,000 per year.

**Oversight** notes this proposal makes changes to the Missouri Returning Heroes' Education Act (Act). The Act currently requires public institutions of higher education in this state to limit the amount of tuition that is paid by combat veterans to no more than \$50 per credit hour. This \$50 per credit hour limit is applied only if the veteran is enrolled in a program leading towards a certificate, associate or baccalaureate degree.

**Oversight** notes this proposal expands the Act to limit the amount that public institutions of higher education can charge for veteran students working toward a graduate degree to no more than 30% of the cost of tuition and fees for those working toward a graduate degree including masters degrees and doctorate degrees.

## ASSUMPTION (continued)

**Oversight** estimates the number of military veterans attending graduate school to be 1,353 based on data from the National Center Education Statistics and the U.S. Census Bureau. Oversight notes the average cost for graduate tuition and fees in Missouri is estimated at \$8,895 per year. If 70% of the graduate tuition and fees were waived, the average amount of waived tuition and fees per year per student would total \$6,226 (\$8,895 \* .70). Oversight has no way to narrow the number of military veterans attending graduate school listed above to only those meeting the criteria for 'combat veterans." Below is the estimated cost for the graduate tuition waiver assuming different qualification rates and participation rates:

**Oversight** requested from the Department of Higher Education the amount of tuition and number of students whose tuition has been waived in the past under this \$50 per credit hour existing program. The Department stated they do not routinely gather this information. The last time they asked the institutions for this information was 2011. At that time the institutions reported the one year tuition waiver listed below:

Based on the information above, **Oversight** notes the cost to the colleges and universities of the existing Missouri Returning Heroes program was approximately \$974,933 in 2011 with 593 veterans participating (a veteran participation rate estimated at approximately 6.4%). Oversight is unable to determine how many eligible veterans would participate in the graduate tuition and fee reduction.

### ASSUMPTION (continued)

According to U.S. Census data, there were 45,086 students in graduate, professional public schools in Missouri in 2016, and 256,181 in college, undergraduate. This equates to approximately 17.6% (45,086 / 256,181). Applying this same percentage to the number of reported students that utilized the current program (593), you could reasonably assume that 104 students would utilize the new program and result in approximately \$647,500 in reduced fees and tuition ( $104 \times 86,226 = 8647,500$ ).

**Oversight** notes both the University of Missouri and Missouri State University reported on their FY 2019 appropriation request, the amount of foregone tuition from the current version of the Missouri Returning Heroes Act:

Assuming a similar the rate of participation relative to the total number of students enrolled in graduate, professional public schools in Missouri (45,086), **Oversight** estimates the following costs:

#### ASSUMPTION (continued)

#### House Amendment 1

Officials from the **Department of Higher Education** and **Department of Public Safety** - **Missouri Veterans Commission** assume the proposal as amended will have no fiscal impact on their organizations.

**Oversight** notes this proposal as amended requires the tuition limitation to be provided <u>after</u> all other federal and state aid is applied. Under current statute, the tuition limitation is provided <u>before</u> all other federal and state aid has been applied.

**Oversight** notes the Missouri Returning Heroes Program was changed by SB 968 in 2016. SB 968 modified the program so the tuition limitation was applied <u>before</u> all other federal and state aid.

**Oversight** notes applying the tuition limitation after all other federal and state aid could result in an in offsetting increase in revenue for universities that would receive tuition at the regular rate from other federal and state benefits for which the veteran is eligible.

**Oversight** was unable to receive some of the agency responses in a timely manner due to the short fiscal note request time. Oversight has presented this fiscal note on the best current information or on information regarding a previous version of the proposal. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

### FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

#### FISCAL DESCRIPTION

This bill requires any institution of higher education that receives state funds to limit the amount of tuition it charges to combat veterans enrolled in a program leading to a graduate degree to no more than 30% of the cost of tuition and fees.

This bill requires the tuition limitation to be provided after all other federal and state aid is applied.

A combat veteran is eligible for the tuition limitation for a 20-year period beginning on the date of the veteran's last discharge from service.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
