FISCAL ANALYSIS

ASSUMPTION

Officials from the **Missouri Ethics Commission (MEC)** assume the proposal would require the MEC to do the following:

- Provide information to public officials and the public as specified in the Commission duties in Section 105.491, 105.955.14 (4), RSMo., about the new statutory requirements; examples include providing education, developing informational materials, telephone and email assistance.
- Provide oversight in adherence to the specific registration would be primarily from receiving written complaints, as established in Section 105.955.14, RSMo., through conducting investigations and the related legal actions.

It is assumed this prohibition would result in a minimal number of complaints; however, if this assumption is incorrect the Commission would require additional staff resources.

MEC assumes the proposal would not fiscally impact their agency.

Officials from the **Missouri House of Representatives** and **Missouri Senate** assume the proposal will have no fiscal impact on their respective organizations.
