FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Public Safety - Missouri Highway Patrol (MHP)** state, currently the Missouri State Highway Patrol mandates employees who are directly involved in officer-involved shootings to attend a counseling session with a mental health professional (not necessarily a psychiatrist), and two additional follow-up sessions if deemed necessary by the attending mental health professional.

MHP states, if adopted, this bill would generate expenses to their agency, ranging between \$300 - \$3,000 per affected employee for psychiatric evaluations. Psychiatric evaluations used by the Patrol in the past for fitness-for-duty examinations generally cost between \$500 and \$1,500 per session for an employee. The current cost per toxicology case, such as an officer-involved shooting is \$239.

Since officer-involved shootings cannot be predicted in advance, it is difficult to estimate the total fiscal impact for any given year. The average number of officer-involved shootings for the Highway Patrol over the last three years is 8.3. This number is rounded up to 9 to account for a possible increase in officer-involved shootings over the next three years.

Psychiatric Evaluations: 9 x \$300 = \$ 2,700 9 x \$3,000 = \$27,000

Expense Range = \$2,700 - \$27,000 per year

Toxicology Case: $9 \times $239 = $2,151$

Total: \$27,000 + \$2,151 = \$29,151

The assumptions used considered the current market rate for professional psychiatric fees as experienced by the Patrol for fitness-for-duty examinations. The Patrol currently provides a minimum of three professional counseling session to officers directly involved in officer-involved shootings, however these services are typically performed by a counseling professional, not necessarily a psychiatrist. Toxicology cases are handled by the Highway Patrol's Crime Laboratory.

In summary, the MHP assumes a cost to the Highway funds of approximately \$29,000 per year.

Officials from the **Missouri Department of Conservation** assume an unknown negative fiscal impact, but likely less than \$100,000 due to the unknown costs of psychiatric evaluations.

Officials from the **Department of Natural Resources** and the **Department of Social Services - State Technical Assistance Team** each assume the proposal would not fiscally impact their respective agencies.

Officials from the **Boone County Sheriff's Department** assume costs will be incurred for each drug test and psychiatric evaluation that must be performed.

Officials from the **Branson Police Department** state this will not result in a change for their agency as their policy already requires the items specified in the bill.

Officials from the Buchanan County Sheriff's Department, Columbia Police Department, Platte County Sheriff's Department, the St. Charles Police Department, and the St. Louis Metropolitan Police Department did not respond to **Oversight's** request for fiscal impact.

FISCAL DESCRIPTION

This bill requires an officer involved in an officer-involved shooting or an officer-involved death to take a drug test and undergo a psychiatric evaluation, and the officer's employing agency shall ensure the requirements are satisfied.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
