FISCAL ANALYSIS

ASSUMPTION

In response to similar legislation from 2017, HCS for HB 1189, officials at the **City of Independence** assumed a loss in revenue of \$138,000 per year from inspections.

Oversight assumes there are other cities and counties who charge a fee on interior inspections of private residences through their local ordinances. However, Oversight is unclear on the number of cities and counties in the state that charge this fee. Therefore, Oversight will assume an unknown loss in revenues for this proposal.

Officials at the **Branson Police Department** assume this bill presents a large fiscal risk to Branson PD and the city as we continue to experience ongoing problems with low rent, extended stay motels that cater to the criminal and drug cultures. Passage of this bill would directly impact our "Tier" system that allows us to hold property owners accountable and require them to take steps to make their properties safer. This bill would tie our agency's hands and allow these property owners to continue their business practices and entice more criminals to take up residence at these locations. There are currently over 40 locations in Branson that have this potential and it is only the Tier system that has allowed us to keep some property owners responsible. Taking this away would have a large financial impact on not only Branson but the state as it can drastically impact tourism by creating an unsafe tourist location.

Officials at the Department of Economic Development, the Department of Labor and Industrial Relations, the Department of Public Safety's Missouri Highway Patrol, the Department of Health and Senior Services, the Department of Mental Health, the Office of Prosecution Services, the Office of the State Public Defender and the State Tax Commission each assume no fiscal impact to their respective agencies from this proposal.

Officials at the **Office of the State Courts Administrator** assume there may be some impact but there is no way to quantify that currently. Any significant changes will be reflected in future budget requests.

Officials at the **Springfield Police Department**, the **Joplin Police Department**, the **City of Branson** and the **City of Kansas City** each assume no fiscal impact to their respective entities from this proposal.

In response to a previous version, officials at **St. Louis County**, **Boone County**, the **Callaway County Commission** and the **City of Springfield** each assumed no fiscal impact to their respective entities from this proposal.

FISCAL DESCRIPTION

This bill prohibits a city or county from adopting or enforcing a residential property licensing ordinance that includes a requirement for periodic interior inspections of privately-owned residential property for city or county code violations. An occupant of privately-owned residential housing may request a city or county inspection at any time to determine code violations. A political subdivision cannot require a seller or transferor of real property to obtain an inspection or permit of the real property in order to sell or transfer the property.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
