## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Public Safety - Missouri Highway Patrol**, the **Boone County Sheriff's Department**, and the **Joplin Police Department** each assume the proposal would not fiscally impact their respective agencies.

Officials from the **Attorney General's Office (AGO)** assume that any potential costs arising from this proposal could be absorbed with existing resources. The AGO may seek additional appropriations if there is a significant increase in litigation.

Officials from the Branson Police Department, the Cass County Sheriff's Department, the Columbia Police Department, the Independence Police Department, the Greene County Sheriff's Department, the Platte County Sheriff's Department, and the St. Louis Metropolitan Police Department did not respond to **Oversight's** request for fiscal impact.
