FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Insurance**, **Financial Institutions and Professional Registration (DIFP)** state that it is unknown what professions may be affected by this legislation in the future.

DIFP assumes section 324.047.7 of this proposal requires a report from the DIFP to the legislature each time a bill is filed proposing a new regulation of a profession or occupation. Each report would require the Department to research other states' laws, Missouri industry statistics, and national industry standards for occupations and professions that the Department has had no previous involvement with.

DIFP also assumes section 324.047.7 of this proposal would require regulatory entities to submit similar and additional information to the Department upon the filing of a bill proposing additional regulation of a profession or occupation, which the Department would then make available to the legislature.

Depending upon the number of reports necessary, the department may need to request additional funding and / or FTE through the budget process to complete such reports.

At this time, the impact of the legislation and the reporting requirement is unknown.

Oversight assumes this proposal establishes guidelines for the regulation of professions not now regulated. The fiscal impact for specific professional regulations will be reflected in the enabling legislation.

Officials from the Department of Agriculture, the Department of Public Safety - Missouri Highway Patrol, the Department of Transportation Department of Revenue, the Department of Health and Senior Services, the Department of Natural Resources each assume the proposal will have no fiscal impact on their respective organizations.
