FISCAL ANALYSIS

ASSUMPTION

Officials at the **City of Grant City** have had a contract with a trash hauler for over 20 years to pick up trash in their community. The City has mandated trash pickup and the billing is done through the City. Each household currently pays \$13.00 per month for trash pickup and the City also does twice yearly citywide cleanup days where customers can place larger items out for pickup and there is no additional cost to the customers.

Please find below just a few of the issues that the City would face if trash pickup were to go to a vote of the people:

- * Added expense of election costs (placing the issue on the ballot)
- * Street damage from larger trucks being used to pick up trash (the City currently uses a small local trash hauler with smaller trucks. The City streets cannot sustain the weight from the larger trucks and the City just completed a \$440,000 street paving project with some streets being paved for the first time in 50 years. If larger trucks are used, the streets would suffer damage and the City would be spending additional funds to resurface and repair the streets or go back to gravel)
- * Higher costs/billing (if each household contracts individually for their trash pickup, each could possibly see an increase in their monthly statement since there would not be as many customers per hauler and the billing would not be done through the City)
- * Cleanliness of the community if not all households signed up for trash pickup
- * The City currently offers twice yearly citywide cleanup through our current trash hauler and these opportunities would go away or add additional costs to the City plus create issues with larger items not being disposed of in the correct way

Officials at the **City of Springfield** assume a potential negative fiscal impact relating to the bill's inherent administrative burden, however, the loss is likely more than \$100,000.

Oversight assumes cities, towns, and villages could have fiscal impact if voter approval is required of any contract for mandated haulers of residential solid waste collection. The amount of costs would be unknown and would depend upon the size of the district and how many other political subdivisions are holding an election at the same time.

Oversight will show a fiscal impact to local government as \$0 to unknown costs for an election.
