FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of the Secretary of State** assume the proposal will have no fiscal impact on their organization.

Officials from the **Office of State Courts Administrator** assume there may be some fiscal impact but there is no way to quantify that currently. Any significant changes will be reflected in future budget requests.

Officials from the **Platte County Board of Elections** assume the cost of a special election held separately could range from \$8,000 to \$70,000 depending on the entity that calls it.

Officials from the **Kansas City Election Board** state it is difficult to determine the fiscal impact but assumes it will be minimal since it seems all available election dates are used and all elections are City wide. It is just reallocating costs from one entity to another.

Officials from the **St. Louis County Election Board** assume the proposal will have a net positive fiscal impact on their organization. It would restrict court decisions to place language on the ballot after the deadline, reducing reprinting costs, legal fees, and court costs.

St. Louis County Election Board believe this would result in a savings of at least \$2,000 for April General Municipal Elections and \$500 for each other election. The cost is higher in April because all current 91 municipalities within St. Louis County are eligible to be on the ballot in Municipal elections.

Oversight notes that there could be a potential savings to Local Election Authorities and potential costs to Local Political Subdivisions or districts. This legislation requires the political subdivision or district to pay for all costs of the special election that could have been submitted at a regular election day but for violation of the ten week notice was called. Oversight assumes since there is no change to the cost for special elections that the cost and savings will net to zero.

Officials from St. Louis City Board of Elections, Clay County Board of Election Commission, and Jackson County Election Board did not respond to **Oversight's** request for fiscal impact.
