AN ACT

To repeal section 304.820, RSMo, and to enact in lieu thereof one new section relating to the use of electronic wireless communication devices, with penalty provisions.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 304.820, RSMo, is repealed and one new section enacted in lieu thereof, to be known as section 304.822, to read as follows:

304.822. 1. As used in this section, the following terms mean:

(1) **"Electronic message", a self-contained piece of digital communication that is designed or intended to be transmitted via an electronic wireless communication device, which includes, but is not limited to, electronic mail, a text message, an instant message, or a command or request to access an internet site;**

(2) **"Electronic wireless communication device", includes, but is not limited to, a cell phone, personal digital assistant, electronic device with mobile data access, laptop computer, pager, broadband personal communication device, electronic game, or portable computing device. An electronic wireless communications device shall not include:**

(a) **A global navigation satellite system receiver used for positioning, emergency notification, or navigation purposes; and**

(b) **Two-way or citizen band radio services;**

(3) **"Hands-free electronic wireless communication device", a wireless communication device that has an internal feature or function, or that is equipped with an attachment or addition, regardless of whether permanently part of such mobile electronic device, by which a user engages with the device without the use of either hand; provided, however, this definition shall not preclude the use of either hand merely to activate, deactivate, or initiate a function of the device;**

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

19 (4) "Highway", any public thoroughfare for vehicles, including state roads, county
20 roads, public streets, avenues, boulevards, parkways, or alleys in any municipality;

21 (5) "Operating", physically driving or operating a motor vehicle on a highway,
22 including operation while temporarily stationary because of traffic, a traffic light or stop
23 sign, or otherwise. A person is not operating a motor vehicle for purposes of this section
24 when the vehicle has pulled over to the side of, or off, a highway and has stopped in a
25 location where it can safely remain stationary.

26 2. Except as otherwise provided in this section, a person operating a noncommercial
27 motor vehicle or commercial motor vehicle, as such terms are defined in section 302.700,
28 upon the highways of this state shall not use any hand-held electronic wireless
29 communications device while operating such vehicle. Prohibited uses shall include, but not
30 be limited to: reading, composing, viewing, or posting any electronic message; initiating,
31 receiving, or conducting a conversation; or manually typing data into any electronic
32 wireless communication device.

33 3. The provisions of subsection 2 of this section shall not apply to a person
34 operating:

35 (1) An authorized emergency vehicle as defined in section 304.022;

36 (2) A motor vehicle that is responding to another motor vehicle's request for
37 roadside assistance upon the highways of this state when such response is conducted in the
38 course and scope of a commercial activity; or

39 (3) A motor vehicle while using a hand-held electronic wireless communications
40 device to:

41 (a) Contact emergency services; or

42 (b) Relay information between a transit or for-hire motor vehicle operator and that
43 operator's dispatcher when the device is affixed to the motor vehicle.

44 4. Nothing contained in subsection 2 of this section shall be construed or
45 interpreted to prohibit a person operating a noncommercial motor vehicle, as such term
46 is defined in section 302.700, on the highways of this state from using a hands-free
47 electronic wireless communication device when the operator is not holding the hands-free
48 electronic wireless communication device in the operator's hand or hands, except the
49 operator shall not have his or her attention diverted from the lawful operation of the
50 noncommercial motor vehicle. The provisions of subsection 2 shall not prohibit the use of
51 either hand merely to activate, deactivate, or initiate a function of a hands-free electronic
52 wireless communication device while operating a non-commercial motor vehicle.

53 5. A violation of this section shall be deemed an infraction punishable by a fifty
54 dollar fine. A violation of this section while operating a motor vehicle in a work zone, as
55 defined in section 304.580; when highway workers, as defined in section 304.580, are

56 present; or in areas designated as a school zone that are visibly marked by traffic control
 57 devices shall be deemed an infraction punishable by a one hundred dollar fine. A violation
 58 of subsection 2 of this section shall not be deemed a moving violation for purposes of point
 59 assessment under section 302.302; however, a violation of subsection 2 of this section shall
 60 be deemed a serious traffic violation, as defined in 302.700, for purposes of commercial
 61 driver's license disqualification under section 302.755.

62 **6. The state preempts the field of regulating the use of hand-held electronic wireless**
 63 **communications devices by the operators of motor vehicles, and the provisions of this**
 64 **section shall supersede any local laws, ordinances, orders, rules, or regulations enacted by**
 65 **a county, municipality, or other political subdivision to regulate the use of hand-held**
 66 **electronic wireless communication devices by the operator of a motor vehicle.**

67 **7. Notwithstanding any provision in this section to the contrary, no person less than**
 68 **eighteen years of age, or with an instruction permit or intermediate license regardless of**
 69 **age, shall use an electronic wireless communications device, regardless of whether such**
 70 **device is hands-free, while operating a motor vehicle on the highways of this state, except**
 71 **to contact emergency services.**

~~2 [304.820. 1. Except as otherwise provided in this section, no person
 3 twenty-one years of age or younger operating a moving motor vehicle upon the
 4 highways of this state shall, by means of a hand-held electronic wireless
 5 communications device, send, read, or write a text message or electronic
 6 message.~~

~~7 2. Except as otherwise provided in this section, no person shall operate
 8 a commercial motor vehicle while using a hand-held mobile telephone.~~

~~9 3. Except as otherwise provided in this section, no person shall operate
 10 a commercial motor vehicle while using a wireless communications device to
 11 send, read, or write a text message or electronic message.~~

~~12 4. The provisions of subsection 1 through subsection 3 of this section
 13 shall not apply to a person operating:~~

~~14 (1) An authorized emergency vehicle; or~~

~~15 (2) A moving motor vehicle while using a hand-held electronic wireless
 16 communications device to:~~

~~17 (a) Report illegal activity;~~

~~18 (b) Summon medical or other emergency help;~~

~~19 (c) Prevent injury to a person or property; or~~

~~20 (d) Relay information between a transit or for-hire operator and that
 21 operator's dispatcher, in which the device is permanently affixed to the vehicle.~~

~~22 5. Nothing in this section shall be construed or interpreted as prohibiting
 23 a person from making or taking part in a telephone call, by means of a hand-held
 24 electronic wireless communications device, while operating a noncommercial
 motor vehicle upon the highways of this state.~~

25 ~~6. As used in this section, "electronic message" means a self-contained~~

31 ~~device" includes any hand-held cellular phone, palm pilot, blackberry, or other~~
32 ~~mobile electronic device used to communicate verbally or by text or electronic~~
33 ~~messaging, but shall not apply to any device that is permanently embedded into~~
34 ~~the architecture and design of the motor vehicle.~~

35 ~~8. As used in this section, "making or taking part in a telephone call"~~
36 ~~means listening to or engaging in verbal communication through a hand-held~~
37 ~~electronic wireless communication device.~~

38 ~~9. As used in this section, "send, read, or write a text message or~~
39 ~~electronic message" means using a hand-held electronic wireless~~
40 ~~telecommunications device to manually communicate with any person by using~~
41 ~~an electronic message. Sending, reading, or writing a text message or electronic~~
42 ~~message does not include reading, selecting, or entering a phone number or name~~
43 ~~into a hand-held electronic wireless communications device for the purpose of~~
44 ~~making a telephone call.~~

45 ~~10. A violation of this section shall be deemed an infraction and shall be~~
46 ~~deemed a moving violation for purposes of point assessment under section~~

48 ~~11. The state preempts the field of regulating the use of hand-held~~
49 ~~electronic wireless communications devices in motor vehicles, and the provisions~~

59 ~~(3) The use of factory-installed or aftermarket global positioning systems~~
60 ~~(GPS) or wireless communications devices used to transmit or receive data as~~

63 ~~(5) The use of two-way radio transmitters or receivers by a licensee of the~~
