AN ACT

To amend chapter 168, RSMo, by adding thereto one new section relating to school librarians.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 168, RSMo, is amended by adding thereto one new section, to be
2 known as section 168.770, to read as follows:

168.770. 1. For purposes of this section, the following terms mean:

2 **(1) "School librarian", a teacher who holds a certificate of license to teach under**
3 **section 168.021 and is certified as a library media specialist by the department of**
4 **elementary and secondary education;**

5 **(2) "School library information and technology program", a school-based program**
6 **that is staffed by a school librarian and that provides a broad, flexible array of services,**
7 **resources, and instruction that support student mastery of the essential academic learning**
8 **requirements and state standards in all subject areas and the implementation of any school**
9 **improvement plan of the district.**

10 **2. Every school board shall provide adequate resources and materials for the**
11 **operation of school library information and technology programs as the board deems**
12 **necessary for the proper education of the district's students or as otherwise required by**
13 **law or rule promulgated by the department of elementary and secondary education.**

14 **3. The school librarian, through the school library information and technology**
15 **program, shall collaborate as an instructional partner to help all students meet the content**
16 **goals in all subject areas and assist high school students in developing plans required for**
17 **graduation from high school and any institutions of higher education.**

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

18 **4. The school librarian’s duties may include, but are not limited to, collaborating**
19 **with his or her schools to:**

20 **(1) Integrate information and technology into the curriculum and instruction**
21 **including, but not limited to, instructing other certificated staff about using and integrating**
22 **information and technology literacy into instruction through workshops, modeling lessons,**
23 **and individual peer coaching;**

24 **(2) Provide students and staff with information management instruction in the**
25 **appropriate use of computers and mobile devices in an educational setting and about how**
26 **to effectively use emerging learning technologies for school and lifelong learning;**

27 **(3) Help teachers and students efficiently and effectively access the highest quality**
28 **information available while using information ethically;**

29 **(4) Instruct students in digital citizenship, including how to be critical consumers**
30 **of information, and provide guidance about thoughtful and strategic use of online**
31 **resources; and**

32 **(5) Create a culture of reading in the school community by developing a diverse,**
33 **student-focused collection of materials that ensures all students can find something of**
34 **quality to read, by facilitating school-wide reading initiatives, and by providing individual**
35 **support and guidance for students.**

36 **5. Before July 1, 2019, the department of elementary and secondary education shall**
37 **develop a process for recognition of a district’s school library information and technology**
38 **program.**

39 **6. The department of elementary and secondary education may promulgate rules**
40 **to implement the provisions of this section. Any rule or portion of a rule, as that term is**
41 **defined in section 536.010, that is created under the authority delegated in this section shall**
42 **become effective only if it complies with and is subject to all of the provisions of chapter**
43 **536 and, if applicable, section 536.028. This section and chapter 536 are nonseverable, and**
44 **if any of the powers vested with the general assembly pursuant to chapter 536 to review,**
45 **to delay the effective date, or to disapprove and annul a rule are subsequently held**
46 **unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted**
47 **after August 28, 2018, shall be invalid and void.**
