3 4	"173.2551. 1. The governing board of any public or private institution of higher education within
5	the state may designate one or more full-time faculty or staff members as campus protection
6	officers. The responsibilities and duties of a campus protection officer are voluntary and shall be in
7	addition to the normal responsibilities and duties of the faculty or staff member. Any compensation
8	for additional duties relating to service as a campus protection officer shall be funded by the
9	institution of higher education.
10	2. Any person designated as a campus protection officer shall be authorized to carry
11	concealed firearms or a self-defense spray device on the campus of the institution of higher
12	education. A "self-defense spray device" shall mean any device that is capable of carrying, and that
13	ejects, releases, or emits, a nonlethal solution capable of incapacitating a violent threat. The campus
14	protection officer shall not be permitted to allow any firearm or self-defense spray device out of his
15	or her personal control while that firearm or device is on property belonging to an institution of
16	higher education. Any campus protection officer who violates this subsection may be subject to
17	employment termination proceedings.
18	3. A campus protection officer has the same authority to detain or use force against any
19	person on campus as provided to any other person under chapter 563.
20	4. Upon detention of a person under subsection 3 of this section, the campus protection
21	officer shall immediately notify the law enforcement agency with jurisdiction over the institution of
22	higher education.
23	5. Any person detained by a campus protection officer shall be turned over to a law
24	enforcement officer as soon as practicably possible and shall not be detained by a campus protection
25	<u>officer for more than one hour.</u>
26	6. Any full-time faculty or staff member of an institution of higher education who seeks to
27	be designated as a campus protection officer shall request such designation in writing and submit it
28	to the administrator responsible for public safety at the institution of higher education. Along with
29	this request, any faculty or staff member seeking to carry a concealed firearm on campus shall also
30	submit proof that he or she has a valid concealed carry endorsement or permit, and all faculty or
31 32	staff members seeking the designation of campus protection officer shall submit a certificate of completion from a campus protection officer training program approved by the director of the
33	department of public safety.
33 34	7. (1) Any institution of higher education that designates a faculty or staff member as a
35	campus protection officer shall, within thirty days, notify, in writing, the director of the department
36	of public safety of the designation, which shall include the following:

4	(2) The director of the department of public safety shall maintain a listing of all persons
5	designated by institutions of higher education as campus protection officers and shall make this list
6	available to all law enforcement agencies.
7	(3) Notwithstanding any other provisions of law to the contrary, any identifying information
8	collected under the authority of this subsection shall not be considered public information and shall
9	not be subject to a request for public records made under chapter 610.
10	8. An institution of higher education may revoke the designation of a person as a campus
11	protection officer for any reason and shall immediately notify the designated campus protection
12	officer in writing of the revocation. The institution shall also, within thirty days of the revocation,
13	notify the director of the department of public safety in writing of the revocation of the designation
14	of such person as a campus protection officer.
15	9. The director of the department of public safety may promulgate all necessary rules and
16	regulations for the administration of this section, including rules establishing training requirements
17	and training programs for campus protection officers designated under this section. Any rule or
18	portion of a rule, as that term is defined in section 536.010, that is created under the authority
19	delegated in this section shall become effective only if it complies with and is subject to all of the
20	provisions of chapter 536 and, if applicable, section 536.028. This section and chapter 536 are
21	nonseverable, and if any of the powers vested with the general assembly pursuant to chapter 536 to
22	review, to delay the effective date, or to disapprove and annul a rule are subsequently held
23	unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted after
24	August 28, 2019, shall be invalid and void."; and
