As used in this chapter, the following terms shall mean: (1) "Age", an age of forty or more years but less than seventy years, except that it shall not be an unlawful employment practice for an employer to require the compulsory retirement of any person who has attained the age of sixty-five and who, for the two-year period immediately before retirement, is employed in a bona fide executive or high policy-making position, if such person is entitled to an immediate nonforfeitable annual retirement benefit from a pension, profit sharing, savings or deferred compensation plan, or any combination of such plans, of the employer, which equals, in the aggregate, at least forty-four thousand dollars; (2) "Because" or "because of", as it relates to the adverse decision or action, the protected criterion was the motivating factor; (3) "Commission", the Missouri commission on human rights; (4) "Complainant", a person who has filed a complaint with the commission alleging that another person has engaged in a prohibited discriminatory practice; (5) "Disability", a physical or mental impairment which substantially limits one or more of a person's major life activities, being regarded as having such an impairment, or a record of having such an impairment, which with or without reasonable accommodation does not interfere with performing the job, utilizing the place of public accommodation, or occupying the dwelling in question. For purposes of this chapter, the term "disability" does not include current, illegal use of or addiction to a controlled substance as such term is defined by section 195.010; however, a person may be considered to have a disability if that person: (a) Has successfully completed a supervised drug rehabilitation program and is no longer engaging in the illegal use of, and is not currently addicted to, a controlled substance or has otherwise been rehabilitated successfully and is no longer engaging in such use and is not currently addicted; (b) Is participating in a supervised rehabilitation program and is no longer engaging in illegal use of controlled substances; or (c) Is erroneously regarded as currently illegally using, or being addicted to, a controlled substance: (6) "Discrimination", conduct proscribed herein, taken because of race, color, religion, national origin, ancestry, sex, [or] sexual orientation, gender identity, age as it relates to employment, disability, or familial status as it relates to housing. Discrimination includes any unfair treatment based on a person's presumed or assumed race, color, religion, national origin, ancestry,

 race, color, religion, national origin, ancestry, sex, sexual orientation, gender identity, disability, or
 familial status;

(2) To discriminate against any person in the terms, conditions, or privileges of sale or rental
 of a dwelling, or in the provision of services or facilities in connection therewith, because of race,
 color, religion, national origin, ancestry, sex, sexual orientation, gender identity, disability, or
 familial status;

42 (3) To make, print, or publish, or cause to be made, printed, or published any notice,

9. As used in this section and sections 213.045 and 213.050, "housing for older persons" 31 32 means housing:

33 (1) Provided under any state or federal program that the commission determines is 34 specifically designed and operated to assist elderly persons, as defined in the state or federal 35 program; 36

(2) Intended for, and solely occupied by, persons sixty-two years of age or older; or

37 (3) Intended and operated for occupancy by at least one person fifty-five years of age or 38 older per unit. In determining whether housing qualifies as housing for older persons under this 39 subsection, the commission shall develop regulations which require at least the following factors:

40 (a) The existence of significant facilities and services specifically designed to meet the 41 physical or social needs of older persons, or if the provision of such facilities and services is not 42 practicable, that such housing is necessary to provide important housing opportunities for older 43 persons; and

44 (b) That at least eighty percent of the units are occupied by at least one person fifty-five 45 years of age or older per unit; and

(c) The publication of, and adherence to, policies and procedures which demonstrate an 46 47 intent by the owner or manager to provide housing for persons fifty-five years of age or older.

48 10. Housing shall not fail to meet the requirements for housing for older persons by reason 49 of:

1 (1) Persons residing in such housing as of August 28, 1992, who do not meet the age 2 requirements of subdivision (2) or (3) of subsection 9 of this section, provided that new occupants of 3 such housing meet the age requirements of subdivision (2) or (3) of subsection 9 of this section; or

4 (2) Unoccupied units, provided that such units are reserved for occupancy by persons who 5 meet the age requirements of subdivision (2) or (3) of subsection 9 of this section.

11. Nothing in this section or section 213.045 or 213.050 shall prohibit conduct against a
person because such person has been convicted by any court of competent jurisdiction of the illegal
manufacture or distribution of a controlled substance, as defined by section 195.010.

9 12. Nothing in this chapter shall prohibit a religious organization, association, or society, or 10 any nonprofit institution or organization operated, supervised or controlled by or in conjunction with a religious organization, association, or society, from limiting the sale, rental or occupancy of 11 12 dwellings which it owns or operates for other than a commercial purpose to persons of the same 13 religion, or from giving preference to such persons, unless membership in such religion is restricted 14 on account of race, color, or national origin. Nor shall anything in this chapter prohibit a private 15 club not in fact open to the public, which as an incident to its primary purpose or purposes provides 16 lodging which it owns or operates for other than a commercial purpose, from limiting the rental or 17 occupancy of such lodging to its members or from giving preference to its members.

Notwithstanding any other provision of this chapter, it shall not be an unlawful

11 employment practice for the state or any political subdivision of the state to comply with the 12 provisions of 29 U.S.C. Section 623 relating to employment as firefighters or law enforcement 13 officers.

213.065. 1. All persons within the jurisdiction of the state of Missouri are free and equal
 and shall be entitled to the full and equal use and enjoyment within this state of any place of public
 accommodation, as hereinafter defined, without discrimination or segregation because of race, color,
 religion, national origin, sex, sexual orientation, gender identity, ancestry, or disability.

2. It is an unlawful discriminatory practice for any person, directly or indirectly, to refuse, withhold from or deny any other person, or to attempt to refuse, withhold from or deny any other person, any of the accommodations, advantages, facilities, services, or privileges made available in any place of public accommodation, as defined in section 213.010 and this section, or to segregate or discriminate against any such person in the use thereof because of race, color, religion, national origin, sex, sexual orientation, gender identity, ancestry, or disability.

The provisions of this section shall not apply to a private club, a place of accommodation owned by or operated on behalf of a religious corporation, association or society, or other establishment which is not in fact open to the public, unless the facilities of such establishments are made available to the customers or patrons of a place of public accommodation as defined in section 213.010 and this section.

29 213.070. 1. It shall be an unlawful discriminatory practice for an employer, employment
 30 agency, labor organization, or place of public accommodation:

(1) To aid, abet, incite, compel, or coerce the commission of acts prohibited under this
 chapter or to attempt to do so;

(2) To retaliate or discriminate in any manner against any other person because such person

4. The general assembly hereby expressly abrogates by this statute the cases of Daugherty v.
City of Maryland Heights, 231 S.W.3d 814 (Mo. 2007) and its progeny as they relate to the
contributing factor standard and abandonment of the burden-shifting framework established in
McDonnell Douglas Corp. v. Green, 411 U.S. 792 (1973).

5. The general assembly hereby expressly abrogates by this statute the holding in Hurst v.
Kansas City Mo. School District, 437 S.W.3d 327 (Mo.App. W.D. 2014), that Missouri Approved
Instruction 19.01 may be applied to actions brought pursuant to this chapter, and the holding in
Thomas v. McKeever's Enterprises, Inc., 388 S.W.3d 206 (Mo.App. W.D. 2012), that juries shall not
be instructed that plaintiffs bear the burden of establishing "but for" causation in actions brought

6. The general assembly hereby abrogates all Missouri-approved jury instructions
specifically addressing civil actions brought under this chapter which were in effect prior to August
28, [2017] 2019."; and
