1 AMEND House Committee Substitute for House Bill No. 160, Page 2, Section 386.264, Line 24, by
2 adding after said section and line the following:

4 "640.142. 1. Within twelve months of the effective date of this section, each public water
5 system shall create a plan that establishes policies and procedures for identifying and mitigating
6 cyber risk. The plan shall include risk assessments and implementation of appropriate controls to
7 mitigate identified cyber risks.

8 2. Public water systems that do not use an internet-connected control system are exempt
9 from the provisions of this section.

10 3. The provisions of this section shall not apply to cities with a population over thirty
11 thousand individuals, a county with a charter form of government and with more than six hundred
12 thousand but fewer than seven hundred thousand inhabitants, or a county with a charter form of
13 government and with more than nine hundred fifty thousand inhabitants.

14 640.144. 1. All public water systems shall be required to create a valve inspection program
15 that includes:

16 (1) Inspection of all valves every ten years;

17 (2) Scheduled repair or replacement of broken valves; and

18 (3) Identification of each valve location using a geographic information system or an
19 alternative physical mapping system that accurately identifies the location of each valve.

20 2. All public water systems shall be required to create a hydrant inspection program that
21 includes:

22 (1) Annual testing of every hydrant in the public water system ;

23 (2) Scheduled repair or replacement of broken hydrants;

24 (3) A plan to flush every hydrant and dead-end main;

25 (4) Maintenance of records of inspections, tests, and flushings for six years; and

26 (5) Identification of each hydrant location using a geographic information system or an
27 alternative physical mapping system that accurately identifies the location of each hydrant.

28 3. The provisions of this section shall not apply to cities with a population over thirty
29 thousand individuals, a county with a charter form of government and with more than six hundred
30 thousand but fewer than seven hundred thousand inhabitants, or a county with a charter form of
31 government and with more than nine hundred fifty thousand inhabitants.

32 640.145. 1. Public water systems shall submit an annual report to the department of natural
33 resources that shall certify compliance with all regulations regarding:

34 (1) Water quality sampling, testing, and reporting;

35 (2) Hydrant and valve inspections under section 640.144; and

36 (3) Cyber security plans and policies, if required under section 640.142.
