15	(2) Allow a person who is determined eligible for advance payments of the premium tax

17	reductions to purchase coverage through the Missouri care plan.
18	4. If the Secretary of the United States Department of Health and Human Services grants
19	any necessary waiver under subsection 3 of this section, the department may enter into a contract
20	with one or more providers of insurance to provide the coverage described in this section to persons
21	who enroll in the Missouri care plan.
22	5. The department shall adopt such regulations as necessary to carry out the provisions of
23 24	this section. Any rule or portion of a rule, as that term is defined in section 536.010, that is created
