1 limited liability partnership may resign without appointing a successor registered agent by paying a 2 fee in the amount of [ten] five dollars to the secretary of state and filing a certificate with the 3 secretary of state stating that it resigns as registered agent for the registered limited liability 4 partnership or foreign registered limited liability partnership identified in the certificate, but such 5 resignation shall not become effective until one hundred twenty days after the certificate is filed. 6 There shall be attached to such certificate an affidavit of such registered agent, if an individual, or 7 the president, a vice president or the secretary thereof if a corporation, that at least thirty days prior 8 to and on or about the date of the filing of the certificate, notices were sent by certified or registered 9 mail to the registered limited liability partnership or foreign registered limited liability partnership 10 for which such registered agent is resigning as registered agent, at the principal office thereof within 11 or outside the state of Missouri, if known to such registered agent or, if not, to the last known 12 address of the attorney or other individual at whose request such registered agent was appointed for 13 such registered limited liability partnership or foreign registered limited liability partnership, of the 14 resignation of such registered agent. After receipt of the notice of the resignation of its registered 15 agent, the registered limited liability partnership or foreign registered limited liability partnership for 16 which such registered agent was acting shall obtain and designate a new registered agent, to take the 17 place of the registered agent so resigning. If such registered limited liability partnership or foreign 18 registered limited liability partnership fails to obtain and designate a new registered agent prior to 19 the expiration of the period of one hundred twenty days after the filing by the registered agent of the 20 certificate of resignation, the application, renewal application or notice filed pursuant to subsection 21 19 of section 358.440 of such registered limited liability partnership or foreign registered limited 22 liability partnership shall be deemed to be cancelled."; and 23 24 Further amend said bill by amending the title, enacting clause, and intersectional references

25 accordingly.
