5	Act of 2019".
6	2. As used in this section, the term "executive agency" shall mean any administrative
7	governmental entity created by the Constitution or statutes of this state under the executive branch,
8	including any department, agency, board, bureau, council, commission, committee, or board of
9	regents or board of curators of any institution of higher learning supported in whole or in part by
10	state funds; any subdivision of an executive agency; and any legally designated agent of such entity.
11	3. The office of administration shall submit to the general assembly and post on the website
12	of the office of administration a report on each capital improvement, building, renovation, or
13	construction project or any information technology project of any type that is funded by an
14	executive agency using only funds appropriated by the general assembly:
15	(1) That is more than one year behind schedule; or
16	(2) For which the amount spent on the project is at least one million dollars more than the
17	original cost estimate for the project.
18	4. To prepare the report required under subsection 3 of this section, the office of
19	administration shall send a request for information to state agencies no later than September first of
20	each year and shall require a response no later than December thirty-first. The office of
21	administration shall submit their report to the general assembly and post it on their website by
22	January thirty-first.
23	5. Each report submitted and posted under subsection 3 of this section shall, for each project
24	included in the report, provide:
25	(1) A brief description of the project, including:
26	(a) The purpose of the project;
27	(b) Each location in which the project is carried out;
28	(c) The year in which the project was initiated;
29	(d) The state's share of the total cost of the project; and
30	(e) Each primary contractor and grant recipient of the project;
31	(2) An explanation of any changes to the original scope of the project, including the addition
32	or narrowing of the initial requirements of the project;
33	(3) The original expected date for completion of the project;
34	(4) The current expected date for completion of the project; (5) The ariginal east estimate for the project as adjusted to reflect increases in the
