5 5. A provisional license issued pursuant to subsection 4 of this section shall only authorize 6 and permit the applicant to render those psychological services which are under the supervision and 7 the full professional responsibility and control of such person's postdoctoral degree licensed 8 supervisor. A provisional license shall automatically terminate upon issuance of a permanent 9 license, upon a finding of cause to discipline after notice and hearing pursuant to section 337.035, 10 upon the expiration of one year from the date of issuance whichever event first occurs, or upon termination of supervision by the licensed supervisor. The provisional license may be renewed after 11 12 one year with a maximum issuance of two years total per provisional licensee. The committee by 13 rule shall provide procedures for exceptions and variances from the requirement of a maximum issuance of two years due to vacations, illness, pregnancy and other good causes. 14

6. The committee, with assistance from the division, shall immediately issue a temporary license to any applicant for licensure either by reciprocity pursuant to section 337.029, or by endorsement of the score from the examination for professional practice in psychology upon receipt of an application for such licensure and upon proof that the applicant is either licensed as a psychologist in another jurisdiction, is a diplomate of the American Board of Professional Psychology, or is a member of the National Register of Health Services Providers in Psychology.

7. A temporary license issued pursuant to subsection 6 of this section shall authorize the
 applicant to practice psychology in this state, the same as if a permanent license had been issued.
 Such temporary license shall be issued without payment of an additional fee and shall remain in full
 force and effect until the earlier of the following events:

(1) A permanent license has been issued to the applicant following successful completion of
 the jurisprudence examination and the oral interview examination;

(2) In cases where the committee has found the applicant ineligible for licensure and no
 appeal has been taken to the administrative hearing commission, then at the expiration of such
 appeal time; or

(3) In cases where the committee has found the applicant ineligible for licensure and the
 applicant has taken an appeal to the administrative hearing commission and the administrative
 hearing commission has also found the applicant ineligible, then upon the rendition by the
 administrative hearing commission of its findings of fact and conclusions of law to such effect.

34 8. Written and oral examinations pursuant to sections 337.010 to 337.090 shall be 35 administered by the committee at least twice each year to any applicant who meets the educational 36 requirements set forth in either section 337.021 or 337.025 or to any applicant who is seeking 37 licensure either by reciprocity pursuant to section 337.029, or by endorsement of the score from the 38 examination of professional practice in psychology. 47 337.025. 1. The provisions of this section shall govern the education and experience
 48 requirements for initial licensure as a psychologist for the following persons:

(1) A person who has not matriculated in a graduate degree program which is primarily

1 psychological in nature on or before August 28, 1990; and 2 (2) A person who is matriculated after August 28, 1990, in a graduate degree program 3 designed to train professional psychologists. 4 2. Each applicant shall submit satisfactory evidence to the committee that the applicant has 5 received a doctoral degree in psychology from a recognized educational institution. [and] has had at 6 least one year of satisfactory supervised professional experience in the field of psychology, and has 7 completed two hours of cultural competency training that meets the guidelines developed by the 8 committee. 9 3. A doctoral degree in psychology is defined as: 10 (1) A program accredited, or provisionally accredited, by the American Psychological Association (APA), the Canadian Psychological Association (CPA), or the Psychological Clinical 11 12 Science Accreditation System (PCSAS); provided that, such program includes a supervised 13 practicum, internship, field, or laboratory training appropriate to the practice of psychology; or 14 (2) A program designated or approved, including provisional approval, by the Association 15 of State and Provincial Psychology Boards or the Council for the National Register of Health 16 Service Providers in Psychology, or both; or 17 (3) A graduate program that meets all of the following criteria: 18 (a) The program, wherever it may be administratively housed, shall be clearly identified and 19 labeled as a psychology program. Such a program shall specify in pertinent institutional catalogues 20 and brochures its intent to educate and train professional psychologists; (b) The psychology program shall stand as a recognizable, coherent organizational entity 21 22 within the institution of higher education; 23 (c) There shall be a clear authority and primary responsibility for the core and specialty 24 areas whether or not the program cuts across administrative lines; 25 (d) The program shall be an integrated, organized, sequence of study; 26 (e) There shall be an identifiable psychology faculty and a psychologist responsible for the 27 program; 28 (f) The program shall have an identifiable body of students who are matriculated in that 29 program for a degree; 30 (g) The program shall include a supervised practicum, internship, field, or laboratory 31 training appropriate to the practice of psychology; 32 (h) The curriculum shall encompass a minimum of three academic years of full-time 33 graduate study, with a minimum of one year's residency at the educational institution granting the 34 doctoral degree; and 35 (i) Require the completion by the applicant of a core program in psychology which shall be 36 met by the completion and award of at least one three-semester-hour graduate credit course or a 37 combination of graduate credit courses totaling three semester hours or five quarter hours in each of 38 the following areas: 39 a. The cognitive-affective bases of behavior such as courses in: learning, thinking, 42 motivation, emotion, and cognitive psychology; 43 c. The social bases of behavior such as courses in: social psychology, group 44 processes/dynamics, interpersonal relationships, and organizational and systems theory; 45 d. Individual differences such as courses in: personality theory, human development, abnormal psychology, developmental psychology, child psychology, adolescent psychology, 46 47 psychology of aging, and theories of personality; 48 e. The scientific methods and procedures of understanding, predicting and influencing 49 human behavior such as courses in: statistics, experimental design, psychometrics, individual

1 testing, group testing, and research design and methodology.

4. Acceptable supervised professional experience may be accrued through preinternship,
internship, predoctoral postinternship, or postdoctoral experiences. The academic training director
or the postdoctoral training supervisor shall attest to the hours accrued to meet the requirements of
this section. Such hours shall consist of:

6 (1) A minimum of fifteen hundred hours of experience in a successfully completed 7 internship to be completed in not less than twelve nor more than twenty-four months; and

8 (2) A minimum of two thousand hours of experience consisting of any combination of the 9 following:

(a) Preinternship and predoctoral postinternship professional experience that occurs
 following the completion of the first year of the doctoral program or at any time while in a doctoral
 program after completion of a master's degree in psychology or equivalent as defined by rule by the
 committee;

(b) Up to seven hundred fifty hours obtained while on the internship under subdivision (1)
of this subsection but beyond the fifteen hundred hours identified in subdivision (1) of this
subsection; or

(c) Postdoctoral professional experience obtained in no more than twenty-four consecutive
calendar months. In no case shall this experience be accumulated at a rate of more than fifty hours
per week. Postdoctoral supervised professional experience for prospective health service providers
and other applicants shall involve and relate to the delivery of psychological services in accordance
with professional requirements and relevant to the applicant's intended area of practice.

22 5. Experience for those applicants who intend to seek health service provider certification and who have completed a program in one or more of the American Psychological Association 23 24 designated health service provider delivery areas shall be obtained under the primary supervision of 25 a licensed psychologist who is also a health service provider or who otherwise meets the 26 requirements for health service provider certification. Experience for those applicants who do not 27 intend to seek health service provider certification shall be obtained under the primary supervision 28 of a licensed psychologist or such other qualified mental health professional approved by the 29 committee.

30 6. For postinternship and postdoctoral hours, the psychological activities of the applicant 31 shall be performed pursuant to the primary supervisor's order, control, and full professional responsibility. The primary supervisor shall maintain a continuing relationship with the applicant 32 33 and shall meet with the applicant a minimum of one hour per month in face-to-face individual 34 supervision. Clinical supervision may be delegated by the primary supervisor to one or more 35 secondary supervisors who are qualified psychologists. The secondary supervisors shall retain 36 order, control, and full professional responsibility for the applicant's clinical work under their 37 supervision and shall meet with the applicant a minimum of one hour per week in face-to-face 38 individual supervision. If the primary supervisor is also the clinical supervisor, meetings shall be a 39 minimum of one hour per week. Group supervision shall not be acceptable for supervised 40 professional experience. The primary supervisor shall certify to the committee that the applicant has 41 complied with these requirements and that the applicant has demonstrated ethical and competent 42 practice of psychology. The changing by an agency of the primary supervisor during the course of 43 the supervised experience shall not invalidate the supervised experience.

The committee by rule shall provide procedures for exceptions and variances from the
 requirements for once a week face-to-face supervision due to vacations, illness, pregnancy, and
 other good causes.

337.050. 1. There is hereby created and established a "State Committee of Psychologists",
which shall consist of seven licensed psychologists and one public member. The state committee of
psychologists existing on August 28, 1989, is abolished. Nothing in this section shall be construed

to prevent the appointment of any current member of the state committee of psychologists to the
 new state committee of psychologists created on August 28, 1989.

3 2. Appointments to the committee shall be made by the governor upon the recommendations 4 of the director of the division, upon the advice and consent of the senate. The division, prior to 5 submitting nominations, shall solicit nominees from professional psychological associations and 6 licensed psychologists in the state. The term of office for committee members shall be five years, 7 and committee members shall not serve more than ten years. No person who has previously served 8 on the committee for ten years shall be eligible for appointment. In making initial appointments to 9 the committee, the governor shall stagger the terms of the appointees so that two members serve 10 initial terms of two years, two members serve initial terms of three years, and two members serve initial terms of four years. 11

12 3. Each committee member shall be a resident of the state of Missouri for one year, shall be 13 a United States citizen, and shall, other than the public member, have been licensed as a 14 psychologist in this state for at least three years. Committee members shall reflect a diversity of 15 practice specialties. To ensure adequate representation of the diverse fields of psychology, the 16 committee shall consist of at least two psychologists who are engaged full time in the doctoral teaching and training of psychologists, and at least two psychologists who are engaged full time in 17 18 the professional practice of psychology. In addition, the first appointment to the committee shall 19 include at least one psychologist who shall be licensed on the basis of a master's degree who shall 20 serve a full term of five years. Nothing in sections 337.010 to 337.090 shall be construed to prohibit full membership rights on the committee for psychologists licensed on the basis of a master's 21 22 degree. If a member of the committee shall, during the member's term as a committee member, remove the member's domicile from the state of Missouri, then the committee shall immediately 23 24 notify the director of the division, and the seat of that committee member shall be declared vacant. 25 All such vacancies shall be filled by appointment of the governor with the advice and consent of the 26 senate, and the member so appointed shall serve for the unexpired term of the member whose seat 27 has been declared vacant.

28 4. The public member shall be at the time of the public member's appointment a citizen of 29 the United States; a resident of this state for a period of one year and a registered voter; a person 30 who is not and never was a member of any profession licensed or regulated pursuant to sections 337.010 to 337.093 or the spouse of such person; and a person who does not have and never has had 31 32 a material, financial interest in either the providing of the professional services regulated by sections 33 337.010 to 337.093, or an activity or organization directly related to any profession licensed or 34 regulated pursuant to sections 337.010 to 337.093. The duties of the public member shall not 35 include the determination of the technical requirements to be met for licensure or whether any 36 person meets such technical requirements or of the technical competence or technical judgment of a 37 licensee or a candidate for licensure.

5. The committee shall hold a regular annual meeting at which it shall select from among its members a chairperson and a secretary. A quorum of the committee shall consist of a majority of its members. In the absence of the chairperson, the secretary shall conduct the office of the chairperson.

6. Each member of the committee shall receive, as compensation, an amount set by the
division not to exceed fifty dollars for each day devoted to the affairs of the committee and shall be
entitled to reimbursement for necessary and actual expenses incurred in the performance of the
member's official duties.

46 7. Staff for the committee shall be provided by the director of the division of professional47 registration.

48 8. The governor may remove any member of the committee for misconduct, inefficiency,49 incompetency, or neglect of office.

9. In addition to the powers set forth elsewhere in sections 337.010 to 337.090, the division may adopt rules and regulations, not otherwise inconsistent with sections 337.010 to 337.090, to carry out the provisions of sections 337.010 to 337.090. The committee may promulgate, by rule, "Ethical Rules of Conduct" governing the practices of psychology which rules shall be based upon the ethical principles promulgated and published by the American Psychological Association.

6 10. Any rule or portion of a rule, as that term is defined in section 536.010, that is 7 promulgated to administer and enforce sections 337.010 to 337.090, shall become effective only if 8 the agency has fully complied with all of the requirements of chapter 536 including but not limited 9 to section 536.028 if applicable, after August 28, 1998. All rulemaking authority delegated prior to 10 August 28, 1998, is of no force and effect and repealed as of August 28, 1998, however nothing in this act shall be interpreted to repeal or affect the validity of any rule adopted and promulgated prior 11 12 to August 28, 1998. If the provisions of section 536.028 apply, the provisions of this section are 13 nonseverable and if any of the powers vested with the general assembly pursuant to section 536.028 14 to review, to delay the effective date, or to disapprove and annul a rule or portion of a rule are held 15 unconstitutional or invalid, the purported grant of rulemaking authority and any rule so proposed 16 and contained in the order of rulemaking shall be invalid and void, except that nothing in this act 17 shall affect the validity of any rule adopted and promulgated prior to August 28, 1998.

The committee may sue and be sued in its official name, and shall have a seal which 19 shall be affixed to all certified copies or records and papers on file, and to such other instruments as 20 the committee may direct.
