1 AMEND Senate Bill No. 358, Page , Section , Line , by inserting after said section and line the  
2 following:

4 "192.067. 1. The department of health and senior services, for purposes of conducting  
5 epidemiological studies to be used in promoting and safeguarding the health of the citizens of  
6 Missouri under the authority of this chapter is authorized to receive information from patient  
7 medical records. The provisions of this section shall also apply to the collection, analysis, and  
8 disclosure of nosocomial infection data from patient records collected pursuant to section 192.667  
9 and to the collection of data under section 192.990.

10 2. The department shall maintain the confidentiality of all medical record information  
11 abstracted by or reported to the department. Medical information secured pursuant to the provisions  
12 of subsection 1 of this section may be released by the department only in a statistical aggregate form  
13 that precludes and prevents the identification of patient, physician, or medical facility except that  
14 medical information may be shared with other public health authorities and coinvestigators of a  
15 health study if they abide by the same confidentiality restrictions required of the department of  
16 health and senior services and except as otherwise authorized by the provisions of sections 192.665  
17 to 192.667, or section 192.990. The department of health and senior services, public health  
18 authorities and coinvestigators shall use the information collected only for the purposes provided for  
19 in this section ~~and~~, section 192.667, or section 192.990.

20 3. No individual or organization providing information to the department in accordance with  
21 this section shall be deemed to be or be held liable, either civilly or criminally, for divulging  
22 confidential information unless such individual organization acted in bad faith or with malicious  
23 purpose.

24 4. The department of health and senior services is authorized to reimburse medical care  
25 facilities, within the limits of appropriations made for that purpose, for the costs associated with  
26 abstracting data for special studies.

27 5. Any department of health and senior services employee, public health authority or  
28 coinvestigator of a study who knowingly releases information which violates the provisions of this  
29 section shall be guilty of a class A misdemeanor and, upon conviction, shall be punished as provided  
30 by law.

31 192.385. 1. There is hereby established in the department of health and senior services the  
32 "Senior Services Growth and Development Program" to provide additional funding for senior  
33 services provided through the area agencies on aging in this state.

34 2. Beginning January 1, 2020, two and one-half percent, and beginning January 1, 2021, and  
35 each year thereafter, five percent of the premium tax collected under sections 148.320 and 148.370,

1 excluding any moneys to be transferred to the state school moneys fund as described in section  
2 148.360, shall be deposited in the fund created in subsection 3 of this section.

3 3. (1) There is hereby created in the state treasury the "Senior Services Growth and  
4 Development Program Fund", which shall consist of moneys collected under this section. The  
5 director of the department of revenue shall collect the moneys described in subsection 2 of this  
6 section and shall remit such moneys to the state treasurer for deposit in the fund, less one percent for  
7 the cost of collection. In accordance with sections 30.170 and 30.180, the state treasurer may  
8 approve disbursements. The fund shall be a dedicated fund and moneys in the fund shall be used  
9 solely by the department of health and senior services for enhancing senior services provided by  
10 area agencies on aging in this state.

11 (2) Notwithstanding the provisions of section 33.080 to the contrary, any moneys remaining  
12 in the fund at the end of the biennium shall not revert to the credit of the general revenue fund. This  
13 fund is not intended to supplant general revenue provided for senior services.

14 (3) The state treasurer shall invest moneys in the fund in the same manner as other funds are  
15 invested. Any interest and moneys earned on such investments shall be credited to the fund.

16 4. The department of health and senior services shall disburse the moneys from the fund to  
17 the area agencies on aging in accordance with the funding formula used by the department to  
18 disburse other federal and state moneys to the area agencies on aging.

19 5. At least fifty percent of all moneys distributed under this section shall be applied by area  
20 agencies on aging to the development and expansion of senior center programs, facilities, and  
21 services.

22 6. All area agencies on aging shall report, either individually or as an association, annually  
23 to the department of health and senior services, the department of insurance, financial institutions  
24 and professional registration, and the general assembly on the distribution and use of moneys under  
25 this section. The board of directors and the advisory board of each area agency on aging shall be  
26 responsible for ensuring the proper use and distribution of such moneys.

27 7. The department of health and senior services may promulgate rules to implement the  
28 provisions of this section. Any rule or portion of a rule, as that term is defined in section 536.010  
29 that is created under the authority delegated in this section shall become effective only if it complies  
30 with and is subject to all of the provisions of chapter 536, and, if applicable, section 536.028. This  
31 section and chapter 536 are nonseverable and if any of the powers vested with the general assembly  
32 pursuant to chapter 536, to review, to delay the effective date, or to disapprove and annul a rule are  
33 subsequently held unconstitutional, then the grant of rulemaking authority and any rule proposed or  
34 adopted after August 28, 2019, shall be invalid and void.

35 192.990. 1. There is hereby established within the department of health and senior services  
36 the "Pregnancy-Associated Mortality Review Board" to improve data collection and reporting with  
37 respect to maternal deaths. The department may collaborate with localities and with other states to  
38 meet the goals of the initiative.

39 2. For purposes of this section, the following terms shall mean:

40 (1) "Department", the Missouri department of health and senior services;

41 (2) "Maternal death", the death of a woman while pregnant or during the one-year period

1 following the date of the end of pregnancy, regardless of the cause of death and regardless of  
 2 whether a delivery, miscarriage, or death occurs inside or outside of a hospital.

3 3. The board shall be composed of no more than eighteen members, with a chair elected  
 4 from among its membership. The board shall meet at least twice per year and shall approve the  
 5 strategic priorities, funding allocations, work processes, and products of the board. Members of the  
 6 board shall be appointed by the director of the department. Members shall serve four-year terms,  
 7 except that the initial terms shall be staggered so that approximately one-third serve three, four, and  
 8 five-year terms.

9 4. The board shall have a multidisciplinary and diverse membership that represents a variety  
 10 of medical and nursing specialties, including, but not limited to, obstetrics and maternal-fetal care,  
 11 as well as state or local public health officials, epidemiologists, statisticians, community  
 12 organizations, geographic regions, and other individuals or organizations that are most affected by  
 13 maternal deaths and lack of access to maternal health care services.

14 5. The duties of the board shall include, but not be limited to:

15 (1) Conducting ongoing comprehensive, multidisciplinary reviews of all maternal deaths;

16 (2) Identifying factors associated with maternal deaths;

17 (3) Reviewing medical records and other relevant data, which shall include, to the extent  
 18 available:

19 (a) A description of the maternal deaths determined by matching each death record of a  
 20 maternal death to a birth certificate of an infant or fetal death record, as applicable, and an indication  
 21 of whether the delivery, miscarriage, or death occurred inside or outside of a hospital;

22 (b) Data collected from medical examiner and coroner reports, as appropriate; and

23 (c) Using other appropriate methods or information to identify maternal deaths, including  
 24 deaths from pregnancy outcomes not identified under paragraph (a) of this subdivision;

25 (4) Consulting with relevant experts, as needed;

26 (5) Analyzing cases to produce recommendations for reducing maternal mortality;

27 (6) Disseminating recommendations to policy makers, health care providers and facilities,  
 28 and the general public;

29 (7) Recommending and promoting preventative strategies and making recommendations for  
 30 systems changes;

31 (8) Protecting the confidentiality of the hospitals and individuals involved in any maternal  
 32 deaths;

33 (9) Examining racial and social disparities in maternal deaths;

34 (10) Subject to appropriation, providing for voluntary and confidential case reporting of  
 35 maternal deaths to the appropriate state health agency by family members of the deceased, and other  
 36 appropriate individuals, for purposes of review by the board;

37 (11) Making publicly available the contact information of the board for use in such  
 38 reporting;

39 (12) Conducting outreach to local professional organizations, community organizations, and  
 40 social services agencies regarding the availability of the review board; and

41 (13) Ensuring that data collected under this section is made available, as appropriate and  
 42 practicable, for research purposes, in a manner that protects individually identifiable or potentially  
 43 identifiable information and that is consistent with state and federal privacy laws.

44 6. The board may contract with other entities consistent with the duties of the board.

45 7. (1) Before June 30, 2020, and annually thereafter, the board shall submit to the Director  
 46 of the Centers for Disease Control and Prevention, the director of the department, the governor, and  
 47 the general assembly a report on maternal mortality in the state based on data collected through  
 48 ongoing comprehensive, multidisciplinary reviews of all maternal deaths, and any other projects or  
 49 efforts funded by the board. The data shall be collected using best practices to reliably determine

1 and include all maternal deaths, regardless of the outcome of the pregnancy and shall include data,  
 2 findings, and recommendations of the committee, and, as applicable, information on the  
 3 implementation during such year of any recommendations submitted by the board in a previous  
 4 year.

5 (2) The report shall be made available to the public on the department's website and the  
 6 director shall disseminate the report to all health care providers and facilities that provide women's  
 7 health services in the state.

8 8. The director of the department, or his or her designee, shall provide the board with the  
 9 copy of the death certificate and any linked birth or fetal death certificate for any maternal death  
 10 occurring within the state.

11 9. Upon request by the department, health care providers, health care facilities, clinics,  
 12 laboratories, medical examiners, coroners, law enforcement agencies, driver's license bureaus, other  
 13 state agencies, and facilities licensed by the department shall provide to the department data related  
 14 to maternal deaths from sources such as medical records, autopsy reports, medical examiner's  
 15 reports, coroner's reports, law enforcement reports, motor vehicle records, social services records,  
 16 and other sources as appropriate. Such data requests shall be limited to maternal deaths which have  
 17 occurred within the previous twenty-four months. No entity shall be held liable for civil damages or  
 18 be subject to any criminal or disciplinary action when complying in good faith with a request from  
 19 the department for information under the provisions of this subsection.

20 10. (1) The board shall protect the privacy and confidentiality of all patients, decedents,  
 21 providers, hospitals, or any other participants involved in any maternal deaths. In no case shall any  
 22 individually identifiable health information be provided to the public or submitted to an information  
 23 clearinghouse.

24 (2) Nothing in this subsection shall prohibit the board or department from publishing  
 25 statistical compilations and research reports that:

26 (a) Are based on confidential information relating to mortality reviews under this section;  
 27 and

28 (b) Do not contain identifying information or any other information that could be used to  
 29 ultimately identify the individuals concerned.

30 (3) Information, records, reports, statements, notes, memoranda, or other data collected  
 31 under this section shall not be admissible as evidence in any action of any kind in any court or  
 32 before any other tribunal, board, agency, or person. Such information, records, reports, notes,  
 33 memoranda, data obtained by the department or any other person, statements, notes, memoranda, or  
 34 other data shall not be exhibited nor their contents disclosed in any way, in whole or in part, by any  
 35 officer or representative of the department or any other person. No person participating in such  
 36 review shall disclose, in any manner, the information so obtained except in strict conformity with  
 37 such review project. Such information shall not be subject to disclosure under chapter 610.

38 (4) All information, records of interviews, written reports, statements, notes, memoranda, or  
 39 other data obtained by the department, the board, and other persons, agencies, or organizations so  
 40 authorized by the department under this section shall be confidential.

41 (5) All proceedings and activities of the board, opinions of members of such board formed  
 42 as a result of such proceedings and activities, and records obtained, created, or maintained under this  
 43 section, including records of interviews, written reports, statements, notes, memoranda, or other data  
 44 obtained by the department or any other person, agency, or organization acting jointly or under  
 45 contract with the department in connection with the requirements of this section, shall be  
 46 confidential and shall not be subject to subpoena, discovery, or introduction into evidence in any  
 47 civil or criminal proceeding; provided, however, that nothing in this section shall be construed to  
 48 limit or restrict the right to discover or use in any civil or criminal proceeding anything that is  
 49 available from another source and entirely independent of the board's proceedings.

(6) Members of the board shall not be questioned in any civil or criminal proceeding regarding the information presented in or opinions formed as a result of a meeting or communication of the board; provided, however, that nothing in this section shall be construed to prevent a member of the board from testifying to information obtained independently of the board or which is public information.

11. The department may use grant program funds to support the efforts of the board and may apply for additional federal government and private foundation grants as needed. The department may also accept private, foundation, city, county, or federal moneys to implement the provisions of this section.

193.015. As used in sections 193.005 to 193.325, unless the context clearly indicates otherwise, the following terms shall mean:

(1) "Advanced practice registered nurse", a person licensed to practice as an advanced practice registered nurse under chapter 335, and who has been delegated tasks outlined in section 193.145 by a physician with whom they have entered into a collaborative practice arrangement under chapter 334;

(2) "Assistant physician", as such term is defined in section 334.036, and who has been delegated tasks outlined in section 193.145 by a physician with whom they have entered into a collaborative practice arrangement under chapter 334;

(3) "Dead body", a human body or such parts of such human body from the condition of which it reasonably may be concluded that death recently occurred;

(4) "Department", the department of health and senior services;

(5) "Final disposition", the burial, interment, cremation, removal from the state, or other authorized disposition of a dead body or fetus;

(6) "Institution", any establishment, public or private, which provides inpatient or outpatient medical, surgical, or diagnostic care or treatment or nursing, custodian, or domiciliary care, or to which persons are committed by law;

(7) "Live birth", the complete expulsion or extraction from its mother of a child, irrespective of the duration of pregnancy, which after such expulsion or extraction, breathes or shows any other evidence of life such as beating of the heart, pulsation of the umbilical cord, or definite movement of voluntary muscles, whether or not the umbilical cord has been cut or the placenta is attached;

(8) "Physician", a person authorized or licensed to practice medicine or osteopathy pursuant to chapter 334;

(9) "Physician assistant", a person licensed to practice as a physician assistant pursuant to chapter 334, and who has been delegated tasks outlined in section 193.145 by a physician with whom they have entered into a ~~[supervision agreement]~~ collaborative practice arrangement under chapter 334;

(10) "Spontaneous fetal death", a noninduced death prior to the complete expulsion or extraction from its mother of a fetus, irrespective of the duration of pregnancy; the death is indicated by the fact that after such expulsion or extraction the fetus does not breathe or show any other evidence of life such as beating of the heart, pulsation of the umbilical cord, or definite movement of voluntary muscles;

(11) "State registrar", state registrar of vital statistics of the state of Missouri;

(12) "System of vital statistics", the registration, collection, preservation, amendment and certification of vital records; the collection of other reports required by sections 193.005 to 193.325 and section 194.060; and activities related thereto including the tabulation, analysis and publication of vital statistics;

(13) "Vital records", certificates or reports of birth, death, marriage, dissolution of marriage and data related thereto;

(14) "Vital statistics", the data derived from certificates and reports of birth, death,

1 spontaneous fetal death, marriage, dissolution of marriage and related reports.

2 198.082. 1. Each certified nursing assistant hired to work in a skilled nursing or  
 3 intermediate care facility after January 1, 1980, shall have successfully completed a nursing  
 4 assistant training program approved by the department or shall enroll in and begin the first available  
 5 approved training program which is scheduled to commence within ninety days of the date of the  
 6 certified nursing assistant's employment and which shall be completed within four months of  
 7 employment. Training programs shall be offered at any facility licensed ~~[or approved]~~ by the  
 8 department of health and senior services; any skilled nursing or intermediate care unit in a Missouri  
 9 veterans home, as defined in section 42.002; or any hospital, as defined in section 197.020. Training  
 10 programs shall be [which is most] reasonably accessible to the enrollees in each class. The program  
 11 may be established by ~~[the]~~ a skilled nursing or intermediate care facility, unit, or hospital; by a  
 12 professional organization<sup>[5]</sup>; or by the department, and training shall be given by the personnel of  
 13 the facility, unit, or hospital; by a professional organization<sup>[5]</sup>; by the department<sup>[5]</sup>; by any  
 14 community college; or by the vocational education department of any high school.

15 2. As used in this section the term "certified nursing assistant" means an employee<sup>[5]</sup> who  
 16 has completed the training required under subsection 1 of this section, who has passed the  
 17 certification exam, and [including a nurse's aide or an orderly,] who is assigned by a skilled nursing  
 18 or intermediate care facility, unit, or hospital to provide or assist in the provision of direct resident  
 19 health care services under the supervision of a nurse licensed under the nursing practice law, chapter  
 20 335.

21 3. This section shall not apply to any person otherwise regulated or licensed to perform  
 22 health care services under the laws of this state. It shall not apply to volunteers or to members of  
 23 religious or fraternal orders which operate and administer the facility, if such volunteers or members  
 24 work without compensation.

 38 ~~nursing skills. All nursing assistants trained prior to January 1, 1989, shall attend, by August 31,~~  
 39 ~~1989, an entire special retraining program established by rule or regulation of the department which~~  
 40 ~~shall contain information on methods of handling mentally confused residents and which may be~~  
 41 ~~offered on premises by the employing facility].~~

42 ~~[4.]~~ 5. Certified nursing assistants who have not successfully completed the nursing assistant  
 43 training program prior to employment may begin duties as a certified nursing assistant ~~[only after~~  
 44 ~~completing an initial twelve hours of basic orientation approved by the department]~~ and may  
 45 provide direct resident care only if under the ~~[general]~~ direct supervision of a licensed nurse prior to  
 46 completion of the seventy-five classroom hours of the training program.

47 6. The competency evaluation shall be performed in a facility, as defined in 42 CFR Sec.  
 48 483.5, or laboratory setting comparable to the setting in which the individual shall function as a  
 49 certified nursing assistant.

1       7. Persons completing the training requirements of unlicensed assistive personnel under 19  
2 CSR 30-20.125 or its successor regulation, and who have completed the competency evaluation,  
3 shall be allowed to sit for the certified nursing assistant examination and be deemed to have fulfilled  
4 the classroom and clinical standards for designation as a certified nursing assistant.

5       8. The department of health and senior services may offer additional training programs and  
6 certifications to students who are already certified as nursing assistants according to regulations  
7 promulgated by the department and curriculum approved by the board.

8       334.037. 1. A physician may enter into collaborative practice arrangements with assistant  
9 physicians. Collaborative practice arrangements shall be in the form of written agreements, jointly  
10 agreed-upon protocols, or standing orders for the delivery of health care services. Collaborative  
11 practice arrangements, which shall be in writing, may delegate to an assistant physician the  
12 authority to administer or dispense drugs and provide treatment as long as the delivery of such  
13 health care services is within the scope of practice of the assistant physician and is consistent with  
14 that assistant physician's skill, training, and competence and the skill and training of the  
15 collaborating physician.

16       2. The written collaborative practice arrangement shall contain at least the following  
17 provisions:

18       (1) Complete names, home and business addresses, zip codes, and telephone numbers of the  
19 collaborating physician and the assistant physician;

20       (2) A list of all other offices or locations besides those listed in subdivision (1) of this  
21 subsection where the collaborating physician authorized the assistant physician to prescribe;

22       (3) A requirement that there shall be posted at every office where the assistant physician is  
23 authorized to prescribe, in collaboration with a physician, a prominently displayed disclosure  
24 statement informing patients that they may be seen by an assistant physician and have the right to  
25 see the collaborating physician;

26       (4) All specialty or board certifications of the collaborating physician and all certifications  
27 of the assistant physician;

28       (5) The manner of collaboration between the collaborating physician and the assistant  
29 physician, including how the collaborating physician and the assistant physician shall:

30       (a) Engage in collaborative practice consistent with each professional's skill, training,  
31 education, and competence;

32       (b) Maintain geographic proximity; except, the collaborative practice arrangement may  
33 allow for geographic proximity to be waived for a maximum of twenty-eight days per calendar year  
34 for rural health clinics as defined by Pub. L. 95-210 (42 U.S.C. Section 1395x), as amended, as long  
35 as the collaborative practice arrangement includes alternative plans as required in paragraph (c) of  
36 this subdivision. Such exception to geographic proximity shall apply only to independent rural  
37 health clinics, provider-based rural health clinics if the provider is a critical access hospital as  
38 provided in 42 U.S.C. Section 1395i-4, and provider-based rural health clinics if the main location  
39 of the hospital sponsor is greater than fifty miles from the clinic. The collaborating physician shall  
40 maintain documentation related to such requirement and present it to the state board of registration  
41 for the healing arts when requested; and

42       (c) Provide coverage during absence, incapacity, infirmity, or emergency by the  
43 collaborating physician;

44       (6) A description of the assistant physician's controlled substance prescriptive authority in  
45 collaboration with the physician, including a list of the controlled substances the physician  
46 authorizes the assistant physician to prescribe and documentation that it is consistent with each  
47 professional's education, knowledge, skill, and competence;

48       (7) A list of all other written practice agreements of the collaborating physician and the  
49 assistant physician;

1 (8) The duration of the written practice agreement between the collaborating physician and  
2 the assistant physician;

3 (9) A description of the time and manner of the collaborating physician's review of the  
4 assistant physician's delivery of health care services. The description shall include provisions that  
5 the assistant physician shall submit a minimum of ten percent of the charts documenting the  
6 assistant physician's delivery of health care services to the collaborating physician for review by the  
7 collaborating physician, or any other physician designated in the collaborative practice arrangement,  
8 every fourteen days; and

9 (10) The collaborating physician, or any other physician designated in the collaborative  
10 practice arrangement, shall review every fourteen days a minimum of twenty percent of the charts in  
11 which the assistant physician prescribes controlled substances. The charts reviewed under this  
12 subdivision may be counted in the number of charts required to be reviewed under subdivision (9) of  
13 this subsection.

14 3. The state board of registration for the healing arts under section 334.125 shall promulgate  
15 rules regulating the use of collaborative practice arrangements for assistant physicians. Such rules  
16 shall specify:

17 (1) Geographic areas to be covered;

18 (2) The methods of treatment that may be covered by collaborative practice arrangements;

19 (3) In conjunction with deans of medical schools and primary care residency program  
20 directors in the state, the development and implementation of educational methods and programs  
21 undertaken during the collaborative practice service which shall facilitate the advancement of the  
22 assistant physician's medical knowledge and capabilities, and which may lead to credit toward a  
23 future residency program for programs that deem such documented educational achievements  
24 acceptable; and

25 (4) The requirements for review of services provided under collaborative practice  
26 arrangements, including delegating authority to prescribe controlled substances.

27  
28 Any rules relating to dispensing or distribution of medications or devices by prescription or  
29 prescription drug orders under this section shall be subject to the approval of the state board of  
30 pharmacy. Any rules relating to dispensing or distribution of controlled substances by prescription  
31 or prescription drug orders under this section shall be subject to the approval of the department of  
32 health and senior services and the state board of pharmacy. The state board of registration for the  
33 healing arts shall promulgate rules applicable to assistant physicians that shall be consistent with  
34 guidelines for federally funded clinics. The rulemaking authority granted in this subsection shall not  
35 extend to collaborative practice arrangements of hospital employees providing inpatient care within  
36 hospitals as defined in chapter 197 or population-based public health services as defined by 20 CSR  
37 2150- 5.100 as of April 30, 2008.

38 4. The state board of registration for the healing arts shall not deny, revoke, suspend, or  
39 otherwise take disciplinary action against a collaborating physician for health care services  
40 delegated to an assistant physician provided the provisions of this section and the rules promulgated  
41 thereunder are satisfied.

42 5. Within thirty days of any change and on each renewal, the state board of registration for  
43 the healing arts shall require every physician to identify whether the physician is engaged in any  
44 collaborative practice arrangement, including collaborative practice arrangements delegating the  
45 authority to prescribe controlled substances, and also report to the board the name of each assistant  
46 physician with whom the physician has entered into such arrangement. The board may make such  
47 information available to the public. The board shall track the reported information and may  
48 routinely conduct random reviews of such arrangements to ensure that arrangements are carried out  
49 for compliance under this chapter.



1           6. A collaborating physician [~~or supervising physician~~] shall not enter into a collaborative  
2 practice arrangement [~~or supervision agreement~~] with more than six full-time equivalent assistant  
3 physicians, full-time equivalent physician assistants, or full-time equivalent advance practice  
4 registered nurses, or any combination thereof. Such limitation shall not apply to collaborative  
5 arrangements of hospital employees providing inpatient care service in hospitals as defined in  
6 chapter 197 or population-based public health services as defined by 20 CSR 2150-5.100 as of April  
7 30, 2008, or to a certified registered nurse anesthetist providing anesthesia services under the  
8 supervision of an anesthesiologist or other physician, dentist, or podiatrist who is immediately  
9 available if needed as set out in subsection 7 of section 334.104.

10           7. The collaborating physician shall determine and document the completion of at least a  
11 one-month period of time during which the assistant physician shall practice with the collaborating  
12 physician continuously present before practicing in a setting where the collaborating physician is not  
13 continuously present. No rule or regulation shall require the collaborating physician to review more  
14 than ten percent of the assistant physician's patient charts or records during such one-month period.  
15 Such limitation shall not apply to collaborative arrangements of providers of population-based  
16 public health services as defined by 20 CSR 2150-5.100 as of April 30, 2008.

17           8. No agreement made under this section shall supersede current hospital licensing  
18 regulations governing hospital medication orders under protocols or standing orders for the purpose  
19 of delivering inpatient or emergency care within a hospital as defined in section 197.020 if such  
20 protocols or standing orders have been approved by the hospital's medical staff and pharmaceutical  
21 therapeutics committee.

22           9. No contract or other agreement shall require a physician to act as a collaborating  
23 physician for an assistant physician against the physician's will. A physician shall have the right to  
24 refuse to act as a collaborating physician, without penalty, for a particular assistant physician. No  
25 contract or other agreement shall limit the collaborating physician's ultimate authority over any  
26 protocols or standing orders or in the delegation of the physician's authority to any assistant  
27 physician, but such requirement shall not authorize a physician in implementing such protocols,  
28 standing orders, or delegation to violate applicable standards for safe medical practice established  
29 by a hospital's medical staff.

30           10. No contract or other agreement shall require any assistant physician to serve as a  
31 collaborating assistant physician for any collaborating physician against the assistant physician's  
32 will. An assistant physician shall have the right to refuse to collaborate, without penalty, with a  
33 particular physician.

34           11. All collaborating physicians and assistant physicians in collaborative practice  
35 arrangements shall wear identification badges while acting within the scope of their collaborative  
36 practice arrangement. The identification badges shall prominently display the licensure status of  
37 such collaborating physicians and assistant physicians.

38           12. (1) An assistant physician with a certificate of controlled substance prescriptive  
39 authority as provided in this section may prescribe any controlled substance listed in Schedule III,  
40 IV, or V of section 195.017, and may have restricted authority in Schedule II, when delegated the  
41 authority to prescribe controlled substances in a collaborative practice arrangement. Prescriptions  
42 for Schedule II medications prescribed by an assistant physician who has a certificate of controlled  
43 substance prescriptive authority are restricted to only those medications containing hydrocodone.  
44 Such authority shall be filed with the state board of registration for the healing arts. The  
45 collaborating physician shall maintain the right to limit a specific scheduled drug or scheduled drug  
46 category that the assistant physician is permitted to prescribe. Any limitations shall be listed in the  
47 collaborative practice arrangement. Assistant physicians shall not prescribe controlled substances  
48 for themselves or members of their families. Schedule III controlled substances and Schedule II -  
49 hydrocodone prescriptions shall be limited to a five-day supply without refill, except that

1 buprenorphine may be prescribed for up to a thirty-day supply without refill for patients receiving

3 physician. Assistant physicians who are authorized to prescribe controlled substances under this  
4 section shall register with the federal Drug Enforcement Administration and the state bureau of

6 number on prescriptions for controlled substances.

7 (2) The collaborating physician shall be responsible to determine and document the  
8 completion of at least one hundred twenty hours in a four-month period by the assistant physician  
9 during which the assistant physician shall practice with the collaborating physician on-site prior to  
10 prescribing controlled substances when the collaborating physician is not on-site. Such limitation  
11 shall not apply to assistant physicians of population-based public health services as defined in 20  
12 CSR 2150-5.100 as of April 30, 2009, or assistant physicians providing opioid addiction treatment.

13 (3) An assistant physician shall receive a certificate of controlled substance prescriptive  
14 authority from the state board of registration for the healing arts upon verification of licensure under  
15 section 334.036.

16 13. Nothing in this section or section 334.036 shall be construed to limit the authority of  
17 hospitals or hospital medical staff to make employment or medical staff credentialing or privileging  
18 decisions.

19 334.104. 1. A physician may enter into collaborative practice arrangements with registered  
20 professional nurses. Collaborative practice arrangements shall be in the form of written agreements,  
21 jointly agreed-upon protocols, or standing orders for the delivery of health care services.  
22 Collaborative practice arrangements, which shall be in writing, may delegate to a registered

29 subdivision (2) of section 335.016. Collaborative practice arrangements may delegate to an  
30 advanced practice registered nurse, as defined in section 335.016, the authority to administer,  
31 dispense, or prescribe controlled substances listed in Schedules III, IV, and V of section 195.017,  
32 and Schedule II - hydrocodone; except that, the collaborative practice arrangement shall not  
33 delegate the authority to administer any controlled substances listed in Schedules III, IV, and V of  
34 section 195.017, or Schedule II - hydrocodone for the purpose of inducing sedation or general  
35 anesthesia for therapeutic, diagnostic, or surgical procedures. Schedule III narcotic controlled  
36 substance and Schedule II - hydrocodone prescriptions shall be limited to a one hundred twenty-  
37 hour supply without refill. Such collaborative practice arrangements shall be in the form of written  
38 agreements, jointly agreed-upon protocols or standing orders for the delivery of health care services.  
39 An advanced practice registered nurse may prescribe buprenorphine for up to a thirty-day supply  
40 without refill for patients receiving medication-assisted treatment for substance use disorders under  
41 the direction of the collaborating physician.

42 3. The written collaborative practice arrangement shall contain at least the following

17 4, and provider-based rural health clinics where the main location of the hospital sponsor is greater  
18 than fifty miles from the clinic. The collaborating physician is required to maintain documentation  
19 related to this requirement and to present it to the state board of registration for the healing arts

21 (c) Provide coverage during absence, incapacity, infirmity, or emergency by the  
22 collaborating physician;

23 (6) A description of the advanced practice registered nurse's controlled substance  
24 prescriptive authority in collaboration with the physician, including a list of the controlled  
25 substances the physician authorizes the nurse to prescribe and documentation that it is consistent  
26 with each professional's education, knowledge, skill, and competence;

27 (7) A list of all other written practice agreements of the collaborating physician and the  
28 advanced practice registered nurse;

29 (8) The duration of the written practice agreement between the collaborating physician and  
30 the advanced practice registered nurse;

31 (9) A description of the time and manner of the collaborating physician's review of the  
32 advanced practice registered nurse's delivery of health care services. The description shall include  
33 provisions that the advanced practice registered nurse shall submit a minimum of ten percent of the

27 334.108. 1. Prior to prescribing any drug, controlled substance, or other treatment through  
28 telemedicine, as defined in section 191.1145, or the internet, a physician shall establish a valid  
29 physician-patient relationship as described in section 191.1146. This relationship shall include:

- 30 (1) Obtaining a reliable medical history and performing a physical examination of the  
31 patient, adequate to establish the diagnosis for which the drug is being prescribed and to identify  
32 underlying conditions or contraindications to the treatment recommended or provided;  
33 (2) Having sufficient dialogue with the patient regarding treatment options and the risks and  
34 benefits of treatment or treatments;

3. Physician assistants shall not perform or prescribe abortions.

4. Physician assistants shall not prescribe any drug, medicine, device or therapy unless pursuant to a [physician supervision agreement] collaborative practice arrangement in accordance with the law, nor prescribe lenses, prisms or contact lenses for the aid, relief or correction of vision or the measurement of visual power or visual efficiency of the human eye, nor administer or monitor general or regional block anesthesia during diagnostic tests, surgery or obstetric procedures. Prescribing of drugs, medications, devices or therapies by a physician assistant shall be pursuant to a [physician assistant supervision agreement] collaborative practice arrangement which is specific to the clinical conditions treated by the supervising physician and the physician assistant shall be subject to the following:

- (1) A physician assistant shall only prescribe controlled substances in accordance with section 334.747;

18 he or she is licensed under the provisions of this chapter. This chapter shall not be construed to  
19 prohibit the use of auxiliary personnel under the direct supervision of a pharmacist from assisting  
20 the pharmacist in any of his or her duties. This assistance in no way is intended to relieve the  
21 pharmacist from his or her responsibilities for compliance with this chapter and he or she will be  
22 responsible for the actions of the auxiliary personnel acting in his or her assistance. This chapter  
23 shall also not be construed to prohibit or interfere with any legally registered practitioner of  
24 medicine, dentistry, or podiatry, or veterinary medicine only for use in animals, or the practice of  
25 optometry in accordance with and as provided in sections 195.070 and 336.220 in the compounding,  
26 administering, prescribing, or dispensing of his or her own prescriptions.

27 2. Any pharmacist who accepts a prescription order for a medication therapeutic plan shall  
28 have a written protocol from the physician who refers the patient for medication therapy services.  
29 The written protocol and the prescription order for a medication therapeutic plan shall come from  
30 the physician only, and shall not come from a nurse engaged in a collaborative practice arrangement  
31 under section 334.104, or from a physician assistant engaged in a ~~[supervision agreement]~~  
32 collaborative practice arrangement under section 334.735.

33 3. Nothing in this section shall be construed as to prevent any person, firm or corporation  
34 from owning a pharmacy regulated by sections 338.210 to 338.315, provided that a licensed  
35 pharmacist is in charge of such pharmacy.

36 4. Nothing in this section shall be construed to apply to or interfere with the sale of  
37 nonprescription drugs and the ordinary household remedies and such drugs or medicines as are  
38 normally sold by those engaged in the sale of general merchandise.

39 5. No health carrier as defined in chapter 376 shall require any physician with which they  
40 contract to enter into a written protocol with a pharmacist for medication therapeutic services.

41 6. This section shall not be construed to allow a pharmacist to diagnose or independently  
42 prescribe pharmaceuticals.

43 7. The state board of registration for the healing arts, under section 334.125, and the state  
44 board of pharmacy, under section 338.140, shall jointly promulgate rules regulating the use of  
45 protocols for prescription orders for medication therapy services and administration of viral  
46 influenza vaccines. Such rules shall require protocols to include provisions allowing for timely  
47 communication between the pharmacist and the referring physician, and any other patient protection  
48 provisions deemed appropriate by both boards. In order to take effect, such rules shall be approved  
49 by a majority vote of a quorum of each board. Neither board shall separately promulgate rules

1 regulating the use of protocols for prescription orders for medication therapy services and  
2 administration of viral influenza vaccines. Any rule or portion of a rule, as that term is defined in  
3 section 536.010, that is created under the authority delegated in this section shall become effective  
4 only if it complies with and is subject to all of the provisions of chapter 536 and, if applicable,  
5 section 536.028. This section and chapter 536 are nonseverable and if any of the powers vested  
6 with the general assembly pursuant to chapter 536 to review, to delay the effective date, or to  
7 disapprove and annul a rule are subsequently held unconstitutional, then the grant of rulemaking  
8 authority and any rule proposed or adopted after August 28, 2007, shall be invalid and void.

9 8. The state board of pharmacy may grant a certificate of medication therapeutic plan  
10 authority to a licensed pharmacist who submits proof of successful completion of a board-approved  
11 course of academic clinical study beyond a bachelor of science in pharmacy, including but not  
12 limited to clinical assessment skills, from a nationally accredited college or university, or a  
13 certification of equivalence issued by a nationally recognized professional organization and  
14 approved by the board of pharmacy.

15 9. Any pharmacist who has received a certificate of medication therapeutic plan authority  
16 may engage in the designing, initiating, implementing, and monitoring of a medication therapeutic  
17 plan as defined by a prescription order from a physician that is specific to each patient for care by a  
18 pharmacist.

19 10. Nothing in this section shall be construed to allow a pharmacist to make a therapeutic  
20 substitution of a pharmaceutical prescribed by a physician unless authorized by the written protocol  
21 or the physician's prescription order.

22 11. "Veterinarian", "doctor of veterinary medicine", "practitioner of veterinary medicine",  
23 "DVM", "VMD", "BVSe", "BVMS", "BSe (Vet Science)", "VMB", "MRCVS", or an equivalent  
24 title means a person who has received a doctor's degree in veterinary medicine from an accredited  
25 school of veterinary medicine or holds an Educational Commission for Foreign Veterinary  
26 Graduates (EDFVG) certificate issued by the American Veterinary Medical Association (AVMA).

27 12. In addition to other requirements established by the joint promulgation of rules by the  
28 board of pharmacy and the state board of registration for the healing arts:

29 (1) A pharmacist shall administer vaccines by protocol in accordance with treatment  
30 guidelines established by the Centers for Disease Control and Prevention (CDC);

31 (2) A pharmacist who is administering a vaccine shall request a patient to remain in the  
32 pharmacy a safe amount of time after administering the vaccine to observe any adverse reactions.  
33 Such pharmacist shall have adopted emergency treatment protocols;

34 (3) In addition to other requirements by the board, a pharmacist shall receive additional  
35 training as required by the board and evidenced by receiving a certificate from the board upon  
36 completion, and shall display the certification in his or her pharmacy where vaccines are delivered.

37 13. A pharmacist shall inform the patient that the administration of the vaccine will be  
38 entered into the ShowMeVax system, as administered by the department of health and senior  
39 services. The patient shall attest to the inclusion of such information in the system by signing a  
40 form provided by the pharmacist. If the patient indicates that he or she does not want such  
41 information entered into the ShowMeVax system, the pharmacist shall provide a written report  
42 within fourteen days of administration of a vaccine to the patient's primary health care provider, if  
43 provided by the patient, containing:

- 44 (1) The identity of the patient;
- 45 (2) The identity of the vaccine or vaccines administered;
- 46 (3) The route of administration;
- 47 (4) The anatomic site of the administration;
- 48 (5) The dose administered; and
- 49 (6) The date of administration.



630.175. 1. No person admitted on a voluntary or involuntary basis to any mental health facility or mental health program in which people are civilly detained pursuant to chapter 632 and no patient, resident or client of a residential facility or day program operated, funded or licensed by the department shall be subject to physical or chemical restraint, isolation or seclusion unless it is determined by the head of the facility, the attending licensed physician, or in the circumstances specifically set forth in this section, by an advanced practice registered nurse in a collaborative practice arrangement, or a physician assistant or an assistant physician with a ~~[supervision agreement]~~ collaborative practice arrangement, with the attending licensed physician that the chosen intervention is imminently necessary to protect the health and safety of the patient, resident, client or others and that it provides the least restrictive environment. An advanced practice registered nurse in a collaborative practice arrangement, or a physician assistant or an assistant physician with a ~~[supervision agreement]~~ collaborative practice arrangement, with the attending licensed physician may make a determination that the chosen intervention is necessary for patients, residents, or clients of facilities or programs operated by the department, in hospitals as defined in section 197.020 that only provide psychiatric care and in dedicated psychiatric units of general acute care hospitals as hospitals are defined in section 197.020. Any determination made by the advanced practice registered nurse, physician assistant, or assistant physician shall be documented as required in subsection 2 of this section and reviewed in person by the attending licensed physician if the episode of restraint is to extend beyond:

- (1) Four hours duration in the case of a person under eighteen years of age;
- (2) Eight hours duration in the case of a person eighteen years of age or older; or
- (3) For any total length of restraint lasting more than four hours duration in a twenty-four-hour period in the case of a person under eighteen years of age or beyond eight hours duration in the case of a person eighteen years of age or older in a twenty-four-hour period.

The review shall occur prior to the time limit specified under subsection 6 of this section and shall be documented by the licensed physician under subsection 2 of this section.

2. Every use of physical or chemical restraint, isolation or seclusion and the reasons therefor shall be made a part of the clinical record of the patient, resident or client under the signature of the head of the facility, or the attending licensed physician, or the advanced practice registered nurse in a collaborative practice arrangement, or a physician assistant or an assistant physician with a ~~[supervision agreement]~~ collaborative practice arrangement, with the attending licensed physician.

3. Physical or chemical restraint, isolation or seclusion shall not be considered standard treatment or habilitation and shall cease as soon as the circumstances causing the need for such action have ended.

4. The use of security escort devices, including devices designed to restrict physical movement, which are used to maintain safety and security and to prevent escape during transport outside of a facility shall not be considered physical restraint within the meaning of this section. Individuals who have been civilly detained under sections 632.300 to 632.475 may be placed in security escort devices when transported outside of the facility if it is determined by the head of the facility, or the attending licensed physician, or the advanced practice registered nurse in a collaborative practice arrangement, or a physician assistant or an assistant physician with a ~~[supervision agreement]~~ collaborative practice arrangement, with the attending licensed physician that the use of security escort devices is necessary to protect the health and safety of the patient, resident, client, or other persons or is necessary to prevent escape. Individuals who have been civilly detained under sections 632.480 to 632.513 or committed under chapter 552 shall be placed in security escort devices when transported outside of the facility unless it is determined by the head of the facility, or the attending licensed physician, or the advanced practice registered nurse in a collaborative practice arrangement, or a physician assistant or an assistant physician with a

1 ~~[supervision agreement]~~ collaborative practice arrangement, with the attending licensed physician  
 2 that security escort devices are not necessary to protect the health and safety of the patient, resident,  
 3 client, or other persons or is not necessary to prevent escape.

4 5. Extraordinary measures employed by the head of the facility to ensure the safety and  
 5 security of patients, residents, clients, and other persons during times of natural or man-made  
 6 disasters shall not be considered restraint, isolation, or seclusion within the meaning of this section.

7 6. Orders issued under this section by the advanced practice registered nurse in a

38 4. Assistant physicians, physician assistants, and advanced practice registered nurses who  
 39 participate in the IATOA program shall complete the necessary requirements to prescribe  
 40 buprenorphine within at least thirty days of joining the IATOA program.

41 5. For the purposes of the IATOA program, a remote collaborating ~~[or supervising]~~  
 42 physician working with an on-site assistant physician, physician assistant, or advanced practice  
 43 registered nurse shall be considered to be on-site. An assistant physician, physician assistant, or  
 44 advanced practice registered nurse collaborating with a remote physician shall comply with all laws

47 6. An assistant physician, physician assistant, or advanced practice registered nurse

2 7. The department may develop curriculum and benchmark examinations on the subject of  
3 opioid addiction and treatment. The department may collaborate with specialists, institutions of  
4 higher education, and medical schools for such development. Completion of such a curriculum and  
5 passing of such an examination by an assistant physician, physician assistant, advanced practice  
6 registered nurse, or physician shall result in a certificate awarded by the department or sponsoring  
7 institution, if any.

8 8. An assistant physician, physician assistant, or advanced practice registered nurse  
9 participating in the IATOA program may also:

- 10 (1) Engage in community education;
- 11 (2) Engage in professional education outreach programs with local treatment providers;

- 13 (4) Serve as a liaison to addiction support organizations;
- 14 (5) Provide educational outreach to schools;
- 15 (6) Treat physical ailments of patients in an addiction treatment program or considering

- 18 (8) Assist patients with court and social service obligations;
