1 AMEND House Bill No. 831, Page 1, Section A, Line 2, by inserting after all of said section and  
2 line the following:

4 "301.3067. 1. Any Missouri resident may receive special license plates as prescribed in this  
5 section after an annual payment of an emblem use authorization fee to the Missouri Association of  
6 Municipal Utilities. The Missouri Association of Municipal Utilities hereby authorizes the use of its  
7 official utility worker emblem to be affixed on multi-year personalized license plates as provided in  
8 this section for any vehicle the person owns, either solely or jointly, other than an apportioned motor  
9 vehicle or commercial motor vehicle licensed in excess of twenty-four thousand pounds gross  
10 weight. Any contribution to such association derived from this section, except reasonable  
11 administrative costs, shall be used solely for financial assistance for utility worker training  
12 programs. Any Missouri resident may annually apply to the association for the use of the emblem.

13 2. Upon annual application and payment of a twenty-five dollar emblem-use contribution to  
14 the Missouri Association of Municipal Utilities, the association shall issue to the vehicle owner,  
15 without further charge, an emblem-use authorization statement, which shall be presented by the  
16 vehicle owner to the department of revenue at the time of registration of a motor vehicle. Upon  
17 presentation of the annual statement and payment of the fee required for personalized licensed plates  
18 in section 301.144, and other fees and documents which may be required by law, the department of  
19 revenue shall issue personalized license plates, which shall bear the emblem of the Missouri  
20 Association of Municipal Utilities utility worker, to the vehicle owner.

21 3. The license plate authorized by this section shall be of a design submitted by the Missouri  
22 Association of Municipal Utilities and approved by the department, shall be made with fully  
23 reflective material with a common color scheme and design, shall be clearly visible at night, and  
24 shall be aesthetically attractive, as prescribed by section 301.130. The bidding process used to  
25 select a vendor for the material to manufacture the license plates authorized by this section shall  
26 consider the aesthetic appearance of the plates.

27 4. A vehicle owner, who was previously issued plates with the Missouri Association of  
28 Municipal Utilities' utility worker emblem authorized by this section but who does not provide an  
29 emblem-use authorization statement at a subsequent time of registration, shall be issued new plates  
30 which do not bear the Missouri Association of Municipal Utilities' utility worker emblem, as  
31 otherwise provided by law. The director of revenue shall make necessary rules and regulations for  
32 the enforcement of this section, and shall design all necessary forms required by this section."; and

34 Further amend said bill by amending the title, enacting clause, and intersectional references  
35 accordingly.
