1 AMEND Senate Bill No. 333, Page 1, Section A, Line 2, by inserting after all of said section and line the
2 following:

4 "8.007. 1. The commission shall:

5 (1) Exercise general supervision of the administration of sections 8.001 to 8.007, including
6 employing staff and retaining such contract services as necessary for performance of the duties and purposes
7 of these sections;

8 (2) Evaluate and approve capitol studies and improvement, expansion, renovation, and restoration
9 projects including, but not limited to, the "21st-Century State Capitol Restoration Project", which includes,
10 but is not limited to, the development and implementation of a comprehensive master plan for the restoration,
11 protection, risk management, and continuing preservation of the capitol building, grounds, and any annex
12 areas. For purposes of this section, "annex areas" shall mean the building currently occupied by the Missouri
13 department of transportation located at 105 West Capitol Avenue in Jefferson City, if used to house members
14 of the general assembly or legislative support staff, or any new building constructed for such purposes;

15 (3) Exercise ongoing supervision and coordination of the capitol building, grounds, and any annex
16 areas;

17 (4) Evaluate and recommend courses of action on the restoration and preservation of the capitol, the
18 preservation of historical significance of the capitol and the history of the capitol;

19 (5) Evaluate and recommend courses of action to ensure accessibility to the capitol for physically
20 disabled persons;

21 (6) Advise, consult, and cooperate with the office of administration, the archives division of the
22 office of the secretary of state, the historic preservation program within the department of natural resources,
23 the division of tourism within the department of economic development and the historical society of Missouri
24 in furtherance of the purposes of sections 8.001 to 8.007;

25 (7) Be authorized to cooperate or collaborate with other state agencies and not-for-profit
26 organizations to publish books and manuals concerning the history of the capitol, its improvement or
27 restoration;

28 (8) On or before October first of each year, submit to the budget director and the general assembly
29 estimates of the requirements for appropriations for the capitol building, grounds, and any annex areas for the
30 year commencing on the following first day of July;

31 (9) Encourage, participate in, or conduct studies, investigations, and research and demonstrations
32 relating to improvement and restoration of the state capitol it may deem advisable and necessary for the
33 discharge of its duties pursuant to sections 8.001 to 8.007;

34 (10) Hold hearings, issue notices of hearings, and take testimony as the commission deems
35 necessary; and

36 (11) Initiate planning efforts, subject to the appropriation of funds, for a centennial celebration of the
37 laying of the capstone of the Missouri state capitol.

38 2. The "State Capitol Commission Fund" is hereby created in the state treasury. Any moneys
39 received from sources other than appropriation by the general assembly, including from private sources, gifts,
40 donations and grants, shall be credited to the state capitol commission fund and shall be appropriated by the

1 general assembly.

2 3. The provisions of section 33.080 to the contrary notwithstanding, moneys in the second capitol
3 commission fund shall not be transferred and placed to the credit of the general revenue fund. Moneys in the
4 state capitol commission fund shall not be appropriated for any purpose other than those designated by the
5 commission.

6 4. The commission is authorized to accept all gifts, bequests and donations from any source
7 whatsoever. The commission may also apply for and receive grants consistent with the purposes of sections
8 8.001 to 8.007. All such gifts, bequests, donations and grants shall be used or expended upon appropriation
9 in accordance with their terms or stipulations, and the gifts, bequests, donations or grants may be used or
10 expended for the preservation, improvement, expansion, renovation, restoration and improved accessibility
11 and for promoting the historical significance of the capitol.

12 5. The commission may copyright or obtain a trademark for any photograph, written work, art
13 object, or any product created of the capitol or capitol grounds. The commission may grant access or use of
14 any such works to other organizations or individuals for a fee, at its sole discretion, or waive all fees. All
15 funds obtained through licensing fees shall be credited to the capitol commission fund in a manner similar to
16 funds the commission receives as gifts, donations, and grants. The funds shall be used for repairs,
17 refurbishing, or to create art, exhibits, decorations, or other beautifications or adornments to the capitol or its
18 grounds.

19 8.111. 1. There is hereby established the "Capitol Police Board" which shall be composed of five
20 members, as follows:

- 21 (1) The governor, or his or her designee;
- 22 (2) The speaker of the house of representatives, or his or her designee;
- 23 (3) The president pro tempore of the senate, or his or her designee;
- 24 (4) The chief justice of the Missouri supreme court, or his or her designee; and
- 25 (5) The chair of the state capitol commission.

27 The lieutenant governor, the chief clerk of the house of representatives, and the secretary of the senate, or
28 their designees, shall serve as ex officio members of the board but shall not have the power to vote. At the
29 first meeting of the board and at yearly intervals thereafter, the members shall select from amongst
30 themselves a chair, a vice chair and a secretary.

31 2. The board shall be assigned to the house of representatives with supervision by the house of
32 representatives only for budgeting and reporting. Such supervision shall not extend to matters relating to
33 policies, regulative functions, or appeals from activities of the board, and no member or employee of the
34 house of representatives shall participate in or interfere with the activities of the board in any manner not
35 specifically provided by law, or at the direction of the board, and no member or employee of the house of
36 representatives shall interfere in any manner with any budget request of or with respect to the withholding of
37 any moneys appropriated to the board by the general assembly.

38 3. The board shall provide for public safety at the seat of government, and for the safety and security
39 of elected officials, government employees, and their guests as needed outside the seat of government. The
40 board shall hire police officers as described in section 8.177.

41 4. The board shall hire a chief of police who shall be certified under chapter 590 and serve subject to
42 the supervision, and at the pleasure, of the board. The chief of police shall:

- 43 (1) Oversee the administrative operations of the capitol police and perform such other duties as may
44 be delegated or assigned to the chief by law or by the board;
- 45 (2) Retain contract services as he or she deems necessary, within the limits authorized by
46 appropriations by the general assembly;
- 47 (3) Appoint a security detail, both inside and outside the seat of government, for the lieutenant
48 governor, members of the general assembly, and any other person when the chief, speaker of the house of
49 representatives, and the president pro tempore deem such security detail necessary.

50 5. The board may promulgate rules relating to the provisions of sections 8.111 to 8.178. Any rule or
51 portion of a rule, as that term is defined in section 536.010 that is created under the authority delegated in this
52 section shall become effective only if it complies with and is subject to all of the provisions of chapter 536,
53 and, if applicable, section 536.028. This section and chapter 536 are nonseverable and if any of the powers

1 vested with the general assembly pursuant to chapter 536, to review, to delay the effective date, or to
 2 disapprove and annul a rule are subsequently held unconstitutional, then the grant of rulemaking authority
 3 and any rule proposed or adopted after August 28, 2019, shall be invalid and void.

4 8.170. The ~~[director]~~ Missouri capitol police shall prosecute, in the name of the state, for all
 5 trespasses and injuries of every kind done to the public buildings and other property, and shall attend to the
 6 suits relative to the same. The attorney general shall give counsel, or prosecute suits, when required by the
 7 ~~[director]~~ chief.

8 8.172. The ~~[commissioner of administration]~~ capitol police board shall make rules and regulations
 9 for the regulation of traffic and parking at all parking space upon the capitol grounds and upon the grounds of
 10 other state buildings located within the capital city. The regulations shall be enforced by the Missouri capitol
 11 police.

12 8.177. 1. The ~~[director of the department of public safety]~~ capitol police board shall employ
 13 Missouri capitol police officers for public safety at the seat of state government. Each Missouri capitol police
 14 officer, upon appointment, shall take and subscribe an oath of office to support the constitution and laws of
 15 the United States and the state of Missouri and shall receive a certificate of appointment, a copy of which
 16 shall be filed with the secretary of state, granting such police officers all the same powers of arrest held by
 17 other police officers to maintain order and preserve the peace in all state-owned or leased buildings, and the
 18 grounds thereof, at the seat of government and such buildings and grounds within the county which contains
 19 the seat of government.

20 2. The ~~[director of the department of public safety]~~ capitol police board shall appoint a sufficient
 21 number of Missouri capitol police officers, with available appropriations, as appropriated specifically for the
 22 purpose designated in this subsection, so that the capitol grounds may be patrolled at all times, and that traffic
 23 and parking upon the capitol grounds and the grounds of other state buildings owned or leased within the
 24 capital city and the county which contains the seat of government may be properly controlled. Missouri
 25 capitol police officers may make arrests for the violation of parking and traffic regulations promulgated by
 26 the office of administration.

27 3. Missouri capitol police officers shall be authorized to arrest a person anywhere in the county that
 28 contains the state seat of government, when there is probable cause to believe the person committed a crime
 29 within capitol police jurisdiction or when a person commits a crime in the presence of an on-duty capitol
 30 police officer.

31 8.178. Any person who violates sections 8.172 to ~~[8.174, or section]~~ 8.177, or any of the traffic or
 32 parking regulations of the ~~[commissioner]~~ capitol police board shall be punished as follows:

33 (1) Fines for traffic violations shall not, except as provided by section 301.143, exceed five dollars
 34 for overparking, fifteen dollars for double parking and fifty dollars for speeding~~[5]~~; and

35 (2) The circuit court of Cole County has authority to enforce ~~[this law]~~ the traffic or parking
 36 regulations of the capitol police board."; and
