8	the house of representatives. There shall be at least two members from the minority party of the senate and at
9	least two members from the minority party of the house of representatives. The members appointed by the
10	governor shall include one member from the health care industry, one member who is a first responder or law
11	enforcement officer, one member who is a member of the judiciary or a prosecuting attorney, and one
12	member representing a substance abuse prevention advocacy group.
13	2. The task force shall select a chairperson and a vice-chairperson, one of whom shall be a member
14	of the senate and one a member of the house of representatives. A majority of the members shall constitute a
15	quorum. The task force shall meet at least once during each legislative session and at all other times as the
16	chairperson may designate.
17	3. The task force shall:
18	(1) Conduct hearings on current and estimated future drug and substance use and abuse within the
19	state;
20	(2) Explore solutions to substance abuse issues; and
21	(3) Draft or modify legislation as necessary to effectuate the goals of finding and funding education
22	and treatment solutions to curb drug and substance use and abuse.
23	4. The task force may make reasonable requests for staff assistance from the research and
24	appropriations staffs of the senate and house of representatives and the joint committee on legislative
25	research. In the performance of its duties, the task force may request assistance or information from all
26	branches of government and state departments, agencies, boards, commissions, and offices.
27	5. The task force shall report annually to the general assembly and the governor. The report shall
28	include recommendations for legislation pertaining to substance abuse prevention and treatment.

Section 353; receipt, transmission, 38 or handling of such orders or facilitating the dispensing of such orders; the designing, initiating, 39 implementing, and monitoring of a medication therapeutic plan as defined by the prescription order so long as 40 the prescription order is specific to each patient for care by a pharmacist; the compounding, dispensing, 41 labeling, and administration of drugs and devices pursuant to medical prescription orders and administration 42 of viral influenza, pneumonia, shingles, hepatitis A, hepatitis B, diphtheria, tetanus, pertussis, and meningitis 43 vaccines by written protocol authorized by a physician for persons at least seven years of age or the age 44 recommended by the Centers for Disease Control and Prevention, whichever is higher, or the administration 45 of pneumonia, shingles, hepatitis A, hepatitis B, diphtheria, tetanus, pertussis, meningitis, and viral influenza 46 vaccines by written protocol authorized by a physician for a specific patient as authorized by rule; the 47 participation in drug selection according to state law and participation in drug utilization reviews; the proper 48 and safe storage of drugs and devices and the maintenance of proper records thereof; consultation with 49 patients and other health care practitioners, and veterinarians and their clients about legend drugs, about the 50 safe and effective use of drugs and devices; the prescribing and dispensing of any nicotine replacement 51 therapy product under section 338.665; and the offering or performing of those acts, services, operations, or 52 transactions necessary in the conduct, operation, management and control of a pharmacy. No person shall 53 engage in the practice of pharmacy unless he or she is licensed under the provisions of this chapter. This

1 chapter shall not be construed to prohibit the use of auxiliary personnel under the direct supervision of a 2 3 pharmacist from assisting the pharmacist in any of his or her duties. This assistance in no way is intended to relieve the pharmacist from his or her responsibilities for compliance with this chapter and he or she will be 4 responsible for the actions of the auxiliary personnel acting in his or her assistance. This chapter shall also 5 not be construed to prohibit or interfere with any legally registered practitioner of medicine, dentistry, or 6 podiatry, or veterinary medicine only for use in animals, or the practice of optometry in accordance with and 7 as provided in sections 195.070 and 336.220 in the compounding, administering, prescribing, or dispensing of 8 his or her own prescriptions. 9 2. Any pharmacist who accepts a prescription order for a medication therapeutic plan shall have a

written protocol from the physician who refers the patient for medication therapy services. The written protocol and the prescription order for a medication therapeutic plan shall come from the physician only, and shall not come from a nurse engaged in a collaborative practice arrangement under section 334.104, or from a physician assistant engaged in a [supervision agreement] collaborative practice arrangement under section 334.735.

3. Nothing in this section shall be construed as to prevent any person, firm or corporation from
 owning a pharmacy regulated by sections 338.210 to 338.315, provided that a licensed pharmacist is in
 charge of such pharmacy.

4. Nothing in this section shall be construed to apply to or interfere with the sale of nonprescription
 drugs and the ordinary household remedies and such drugs or medicines as are normally sold by those
 engaged in the sale of general merchandise.

5. No health carrier as defined in chapter 376 shall require any physician with which they contract to enter into a written protocol with a pharmacist for medication therapeutic services.

6. This section shall not be construed to allow a pharmacist to diagnose or independently prescribe
 pharmaceuticals.

25 7. The state board of registration for the healing arts, under section 334.125, and the state board of 26 pharmacy, under section 338.140, shall jointly promulgate rules regulating the use of protocols for 27 prescription orders for medication therapy services and administration of viral influenza vaccines. Such rules 28 shall require protocols to include provisions allowing for timely communication between the pharmacist and 29 the referring physician, and any other patient protection provisions deemed appropriate by both boards. In 30 order to take effect, such rules shall be approved by a majority vote of a quorum of each board. Neither 31 board shall separately promulgate rules regulating the use of protocols for prescription orders for medication 32 therapy services and administration of viral influenza vaccines. This section and chapter 536 are nonseverable and if any of the powers vested with the general 36 assembly pursuant to chapter 536 to review, to delay the effective date, or to disapprove and annul a rule are 37 subsequently held unconstitutional, then the grant of rulemaking authority and any rule proposed or adopted 38 after August 28, 2007, shall be invalid and void.

39 8. The state board of pharmacy may grant a certificate of medication therapeutic plan authority to a 40 licensed pharmacist who submits proof of successful completion of a board-approved course of academic 41 clinical study beyond a bachelor of science in pharmacy, including but not limited to clinical assessment 42 skills, from a nationally accredited college or university, or a certification of equivalence issued by a 43 nationally recognized professional organization and approved by the board of pharmacy.

44 9. Any pharmacist who has received a certificate of medication therapeutic plan authority may
45 engage in the designing, initiating, implementing, and monitoring of a medication therapeutic plan as defined
46 by a prescription order from a physician that is specific to each patient for care by a pharmacist.

47 10. Nothing in this section shall be construed to allow a pharmacist to make a therapeutic
48 substitution of a pharmaceutical prescribed by a physician unless authorized by the written protocol or the
49 physician's prescription order.

11. "Veterinarian", "doctor of veterinary medicine", "practitioner of veterinary medicine", "DVM",
"VMD", "BVSe", "BVMS", "BSe (Vet Science)", "VMB", "MRCVS", or an equivalent title means a person
who has received a doctor's degree in veterinary medicine from an accredited school of veterinary medicine
or holds an Educational Commission for Foreign Veterinary Graduates (EDFVG) certificate issued by the

1 American Veterinary Medical Association (AVMA).

2 3 12. In addition to other requirements established by the joint promulgation of rules by the board of pharmacy and the state board of registration for the healing arts:

4 (1) A pharmacist shall administer vaccines by protocol in accordance with treatment guidelines 5 established by the Centers for Disease Control and Prevention (CDC);

6 (2) A pharmacist who is administering a vaccine shall request a patient to remain in the pharmacy a 7 safe amount of time after administering the vaccine to observe any adverse reactions. Such pharmacist shall 8 have adopted emergency treatment protocols;

9 (3) In addition to other requirements by the board, a pharmacist shall receive additional training as 10 required by the board and evidenced by receiving a certificate from the board upon completion, and shall 11 display the certification in his or her pharmacy where vaccines are delivered.

If the 15 patient indicates that he or she does not want such information entered into the ShowMeVax system, the 16 pharmacist shall provide a written report within fourteen days of administration of a vaccine to the patient's 17 primary health care provider, if provided by the patient, containing:

24 338.015. 1. The provisions of sections 338.010 to 338.015 shall not be construed to inhibit the 25 patient's freedom of choice to obtain prescription services from any licensed pharmacist. However, nothing 26 in sections 338.010 to 338.315 abrogates the patient's ability to waive freedom of choice under any contract 27 with regard to payment or coverage of prescription expense.

28 2. All pharmacists may provide pharmaceutical consultation and advice to persons concerning the 29 safe and therapeutic use of their prescription drugs.

30 3. All patients shall have the right to receive a written prescription from their prescriber to take to the 31 facility of their choice or to have an electronic prescription transmitted to the facility of their choice.

32 338.055. 1. The board may refuse to issue any certificate of registration or authority, permit or 33 license required pursuant to this chapter for one or any combination of causes stated in subsection 2 of this 34 section or if the designated pharmacist-in-charge, manager-in-charge, or any officer, owner, manager, or 35 controlling shareholder of the applicant has committed any act or practice in subsection 2 of this section. (4) Obtaining or attempting to obtain any fee, charge, tuition or other compensation by fraud,

2 (5) Incompetence, misconduct, gross negligence, fraud, misrepresentation or dishonesty in the 3 performance of the functions or duties of any profession licensed or regulated by this chapter;

4 (6) Violation of, or assisting or enabling any person to violate, any provision of this chapter, or of 5 any lawful rule or regulation adopted pursuant to this chapter;

9 (8) Denial of licensure to an applicant or disciplinary action against an applicant or the holder of a 10 license or other right to practice any profession regulated by this chapter granted by another state, territory, 11 federal agency, or country whether or not voluntarily agreed to by the licensee or applicant, including, but not 12 limited to, surrender of the license upon grounds for which denial or discipline is authorized in this state;

13 14 (9) A person is finally adjudged incapacitated by a court of competent jurisdiction;

(10) Assisting or enabling any person to practice or offer to practice any profession licensed or
 regulated by this chapter who is not registered and currently eligible to practice under this chapter;

(11) Issuance of a certificate of registration or authority, permit or license based upon a material
 mistake of fact;

18 (12) Failure to display a valid certificate or license if so required by this chapter or any rulepromulgated hereunder;

(13) Violation of any professional trust or confidence;

(14) Use of any advertisement or solicitation which is false, misleading or deceptive to the general public or persons to whom the advertisement or solicitation is primarily directed;

(15) Violation of the drug laws or rules and regulations of this state, any other state or the federal

(16) The intentional act of substituting or otherwise changing the content, formula or brand of any drug prescribed by written, <u>electronic</u>, or oral prescription without prior written or oral approval from the prescriber for the respective change in each prescription; provided, however, that nothing contained herein shall prohibit a pharmacist from substituting or changing the brand of any drug as provided under section 338.056, and any such substituting or changing of the brand of any drug as provided for in section 338.056 shall not be deemed unprofessional or dishonorable conduct unless a violation of section 338.056 occurs;

(17) Personal use or consumption of any controlled substance unless it is prescribed, dispensed, or
 administered by a health care provider who is authorized by law to do so.

33 3. After the filing of such complaint, the proceedings shall be conducted in accordance with the 34 provisions of chapter 621. Except as provided in subsection 2 of this section, the pharmacist filling prescription 14 orders for drug products prescribed by trade or brand name may select another drug product with the same 15 active chemical ingredients of the same strength, quantity and dosage form, and of the same generic drug or 16 interchangeable biological product type, as determined by the United States Adopted Names and accepted by 17 the Federal Food and Drug Administration.
