The court may appoint a guardian ad litem or court-appointed special advocate to represent the minor child in accordance with chapter 452 whenever the custodial parent alleges that visitation with the noncustodial parent will damage the minor child.

The court shall make an order requiring the noncustodial party to pay an amount 9 reasonable and necessary for the support of any child to whom the party owes a duty of support 10 when no prior order of support is outstanding and after all relevant factors have been considered, in 11 accordance with Missouri supreme court rule 88.01 and chapter 452.

[8-] 9. The court may grant a maintenance order to a party for a period of time, not to exceed
 one hundred eighty days. Any maintenance ordered by the court shall be in accordance with chapter

[9.] 10. (1) The court may, in order to ensure that a petitioner can maintain an existing
wireless telephone number or numbers, issue an order, after notice and an opportunity to be heard,
directing a wireless service provider to transfer the billing responsibility for and rights to the
wireless telephone number or numbers to the petitioner, if the petitioner is not the wireless service
accountholder.

(2) (a) The order transferring billing responsibility for and rights to the wireless telephone
number or numbers to the petitioner shall list the name and billing telephone number of the
accountholder, the name and contact information of the person to whom the telephone number or
numbers will be transferred, and each telephone number to be transferred to that person. The court
shall ensure that the contact information of the petitioner is not provided to the accountholder in
proceedings held under this chapter.

(b) Upon issuance, a copy of the full order of protection shall be transmitted, either
electronically or by certified mail, to the wireless service provider's registered agent listed with the
secretary of state, or electronically to the email address provided by the wireless service provider.
Such transmittal shall constitute adequate notice for the wireless service provider acting under this
section and section 455.523.

(c) If the wireless service provider cannot operationally or technically effectuate the order
 due to certain circumstances, the wireless service provider shall notify the petitioner within three
 business days. Such circumstances shall include, but not be limited to, the following:

a. The accountholder has already terminated the account;

b. The differences in network technology prevent the functionality of a device on thenetwork; or

c. There are geographic or other limitations on network or service availability.

(3) (a) Upon transfer of billing responsibility for and rights to a wireless telephone number
 or numbers to the petitioner under this subsection by a wireless service provider, the petitioner shall
