1 AMEND House Bill No. 1211, Page 1, Section A, Line 2, by inserting after said section and line the
2 following:

3
4 "301.010. As used in this chapter and sections 304.010 to 304.040, 304.120 to 304.260, and
5 sections 307.010 to 307.175, the following terms mean:

6 (1) "All-terrain vehicle", any motorized vehicle manufactured and used exclusively for off-
7 highway use which is fifty inches or less in width, with an unladen dry weight of one thousand five
8 hundred pounds or less, traveling on three, four or more nonhighway tires;

9 (2) "Autocycle", a three-wheeled motor vehicle which the drivers and passengers ride in a
10 partially or completely enclosed nonstraddle seating area, that is designed to be controlled with a
11 steering wheel and pedals, and that has met applicable Department of Transportation National
12 Highway Traffic Safety Administration requirements or federal motorcycle safety standards;

13 (3) "Automobile transporter", any vehicle combination capable of carrying cargo on the
14 power unit and designed and used for the transport of assembled motor vehicles, including truck
15 camper units;

16 (4) "Axle load", the total load transmitted to the road by all wheels whose centers are
17 included between two parallel transverse vertical planes forty inches apart, extending across the full
18 width of the vehicle;

19 (5) "Backhaul", the return trip of a vehicle transporting cargo or general freight, especially
20 when carrying goods back over all or part of the same route;

21 (6) "Boat transporter", any vehicle combination capable of carrying cargo on the power unit
22 and designed and used specifically to transport assembled boats and boat hulls. Boats may be
23 partially disassembled to facilitate transporting;

24 (7) "Body shop", a business that repairs physical damage on motor vehicles that are not
25 owned by the shop or its officers or employees by mending, straightening, replacing body parts, or
26 painting;

27 (8) "Bus", a motor vehicle primarily for the transportation of a driver and eight or more
28 passengers but not including shuttle buses;

29 (9) "Commercial motor vehicle", a motor vehicle designed or regularly used for carrying
30 freight and merchandise, or more than eight passengers but not including vanpools or shuttle buses;

31 (10) "Cotton trailer", a trailer designed and used exclusively for transporting cotton at
32 speeds less than forty miles per hour from field to field or from field to market and return;

33 (11) "Dealer", any person, firm, corporation, association, agent or subagent engaged in the
34 sale or exchange of new, used or reconstructed motor vehicles or trailers;

35 (12) "Director" or "director of revenue", the director of the department of revenue;

36 (13) "Driveaway operation":

1 (a) The movement of a motor vehicle or trailer by any person or motor carrier other than a
2 dealer over any public highway, under its own power singly, or in a fixed combination of two or
3 more vehicles, for the purpose of delivery for sale or for delivery either before or after sale;

4 (b) The movement of any vehicle or vehicles, not owned by the transporter, constituting the
5 commodity being transported, by a person engaged in the business of furnishing drivers and
6 operators for the purpose of transporting vehicles in transit from one place to another by the
7 driveaway or towaway methods; or

8 (c) The movement of a motor vehicle by any person who is lawfully engaged in the business
9 of transporting or delivering vehicles that are not the person's own and vehicles of a type otherwise
10 required to be registered, by the driveaway or towaway methods, from a point of manufacture,
11 assembly or distribution or from the owner of the vehicles to a dealer or sales agent of a
12 manufacturer or to any consignee designated by the shipper or consignor;

13 (14) "Dromedary", a box, deck, or plate mounted behind the cab and forward of the fifth
14 wheel on the frame of the power unit of a truck tractor-semitrailer combination. A truck tractor
15 equipped with a dromedary may carry part of a load when operating independently or in a
16 combination with a semitrailer;

17 (15) "Farm tractor", a tractor used exclusively for agricultural purposes;

18 (16) "Fleet", any group of ten or more motor vehicles owned by the same owner;

19 (17) "Fleet vehicle", a motor vehicle which is included as part of a fleet;

20 (18) "Fullmount", a vehicle mounted completely on the frame of either the first or last
21 vehicle in a saddlemount combination;

22 (19) "Gross weight", the weight of vehicle and/or vehicle combination without load, plus the
23 weight of any load thereon;

24 (20) "Hail-damaged vehicle", any vehicle, the body of which has become dented as the
25 result of the impact of hail;

26 (21) "Highway", any public thoroughfare for vehicles, including state roads, county roads
27 and public streets, avenues, boulevards, parkways or alleys in any municipality;

28 (22) "Improved highway", a highway which has been paved with gravel, macadam,
29 concrete, brick or asphalt, or surfaced in such a manner that it shall have a hard, smooth surface;

30 (23) "Intersecting highway", any highway which joins another, whether or not it crosses the
31 same;

32 (24) "Junk vehicle", a vehicle which:

33 (a) Is incapable of operation or use upon the highways and has no resale value except as a
34 source of parts or scrap; or

35 (b) Has been designated as junk or a substantially equivalent designation by this state or any
36 other state;

37 (25) "Kit vehicle", a motor vehicle assembled by a person other than a generally recognized
38 manufacturer of motor vehicles by the use of a glider kit or replica purchased from an authorized
39 manufacturer and accompanied by a manufacturer's statement of origin;

40 (26) "Land improvement contractors' commercial motor vehicle", any not-for-hire
41 commercial motor vehicle the operation of which is confined to:

42 (a) An area that extends not more than a radius of one hundred miles from its home base of
43 operations when transporting its owner's machinery, equipment, or auxiliary supplies to or from
44 projects involving soil and water conservation, or to and from equipment dealers' maintenance
45 facilities for maintenance purposes; or

46 (b) An area that extends not more than a radius of fifty miles from its home base of
47 operations when transporting its owner's machinery, equipment, or auxiliary supplies to or from
48 projects not involving soil and water conservation.
49

1 Nothing in this subdivision shall be construed to prevent any motor vehicle from being registered as
2 a commercial motor vehicle or local commercial motor vehicle;

3 (27) "Local commercial motor vehicle", a commercial motor vehicle whose operations are
4 confined to a municipality and that area extending not more than fifty miles therefrom, or a
5 commercial motor vehicle whose property-carrying operations are confined solely to the
6 transportation of property owned by any person who is the owner or operator of such vehicle to or
7 from a farm owned by such person or under the person's control by virtue of a landlord and tenant
8 lease; provided that any such property transported to any such farm is for use in the operation of
9 such farm;

10 (28) "Local log truck", a commercial motor vehicle which is registered pursuant to this
11 chapter to operate as a motor vehicle on the public highways of this state, used exclusively in this
12 state, used to transport harvested forest products, operated solely at a forested site and in an area
13 extending not more than a one hundred mile radius from such site, carries a load with dimensions
14 not in excess of twenty-five cubic yards per two axles with dual wheels, and when operated on the
15 national system of interstate and defense highways described in 23 U.S.C. Section 103, as amended,
16 or outside the one hundred mile radius from such site with an extended distance local log truck
17 permit, such vehicle shall not exceed the weight limits of section 304.180, does not have more than
18 four axles, and does not pull a trailer which has more than three axles. Harvesting equipment which
19 is used specifically for cutting, felling, trimming, delimbing, debarking, chipping, skidding, loading,
20 unloading, and stacking may be transported on a local log truck. A local log truck may not exceed
21 the limits required by law, however, if the truck does exceed such limits as determined by the
22 inspecting officer, then notwithstanding any other provisions of law to the contrary, such truck shall
23 be subject to the weight limits required by such sections as licensed for eighty thousand pounds;

24 (29) "Local log truck tractor", a commercial motor vehicle which is registered under this
25 chapter to operate as a motor vehicle on the public highways of this state, used exclusively in this
26 state, used to transport harvested forest products, operated at a forested site and in an area extending
27 not more than a one hundred mile radius from such site, operates with a weight not exceeding
28 twenty-two thousand four hundred pounds on one axle or with a weight not exceeding forty-four
29 thousand eight hundred pounds on any tandem axle, and when operated on the national system of
30 interstate and defense highways described in 23 U.S.C. Section 103, as amended, or outside the one
31 hundred mile radius from such site with an extended distance local log truck permit, such vehicle
32 does not exceed the weight limits contained in section 304.180, and does not have more than three
33 axles and does not pull a trailer which has more than three axles. Violations of axle weight
34 limitations shall be subject to the load limit penalty as described for in sections 304.180 to 304.220;

35 (30) "Local transit bus", a bus whose operations are confined wholly within a municipal
36 corporation, or wholly within a municipal corporation and a commercial zone, as defined in section
37 390.020, adjacent thereto, forming a part of a public transportation system within such municipal
38 corporation and such municipal corporation and adjacent commercial zone;

39 (31) "Log truck", a vehicle which is not a local log truck or local log truck tractor and is
40 used exclusively to transport harvested forest products to and from forested sites which is registered
41 pursuant to this chapter to operate as a motor vehicle on the public highways of this state for the
42 transportation of harvested forest products;

43 (32) "Major component parts", the rear clip, cowl, frame, body, cab, front-end assembly, and
44 front clip, as those terms are defined by the director of revenue pursuant to rules and regulations or
45 by illustrations;

46 (33) "Manufacturer", any person, firm, corporation or association engaged in the business of
47 manufacturing or assembling motor vehicles, trailers or vessels for sale;

48 (34) "Motor change vehicle", a vehicle manufactured prior to August, 1957, which receives
49 a new, rebuilt or used engine, and which used the number stamped on the original engine as the

1 vehicle identification number;

2 (35) "Motor vehicle", any self-propelled vehicle not operated exclusively upon tracks,
3 except farm tractors;

4 (36) "Motor vehicle primarily for business use", any vehicle other than a recreational motor
5 vehicle, motorcycle, motortricycle, or any commercial motor vehicle licensed for over twelve
6 thousand pounds:

7 (a) Offered for hire or lease; or

8 (b) The owner of which also owns ten or more such motor vehicles;

9 (37) "Motorcycle", a motor vehicle operated on two wheels;

10 (38) "Motorized bicycle", any two-wheeled or three-wheeled device having an automatic
11 transmission and a motor with a cylinder capacity of not more than fifty cubic centimeters, which
12 produces less than three gross brake horsepower, and is capable of propelling the device at a
13 maximum speed of not more than thirty miles per hour on level ground;

14 (39) "Motortricycle", a motor vehicle upon which the operator straddles or sits astride that is
15 designed to be controlled by handle bars and is operated on three wheels, including a motorcycle
16 while operated with any conveyance, temporary or otherwise, requiring the use of a third wheel. A
17 motortricycle shall not be included in the definition of all-terrain vehicle;

18 (40) "Municipality", any city, town or village, whether incorporated or not;

19 (41) "Nonresident", a resident of a state or country other than the state of Missouri;

20 (42) "Non-USA-std motor vehicle", a motor vehicle not originally manufactured in
21 compliance with United States emissions or safety standards;

22 (43) "Operator", any person who operates or drives a motor vehicle;

23 (44) "Owner", any person, firm, corporation or association, who holds the legal title to a
24 vehicle or in the event a vehicle is the subject of an agreement for the conditional sale or lease
25 thereof with the right of purchase upon performance of the conditions stated in the agreement and
26 with an immediate right of possession vested in the conditional vendee or lessee, or in the event a
27 mortgagor of a vehicle is entitled to possession, then such conditional vendee or lessee or mortgagor
28 shall be deemed the owner;

29 (45) "Public garage", a place of business where motor vehicles are housed, stored, repaired,
30 reconstructed or repainted for persons other than the owners or operators of such place of business;

31 (46) "Rebuilder", a business that repairs or rebuilds motor vehicles owned by the rebuilder,
32 but does not include certificated common or contract carriers of persons or property;

33 (47) "Reconstructed motor vehicle", a vehicle that is altered from its original construction
34 by the addition or substitution of two or more new or used major component parts, excluding motor
35 vehicles made from all new parts, and new multistage manufactured vehicles;

36 (48) "Recreational motor vehicle", any motor vehicle designed, constructed or substantially
37 modified so that it may be used and is used for the purposes of temporary housing quarters,
38 including therein sleeping and eating facilities which are either permanently attached to the motor
39 vehicle or attached to a unit which is securely attached to the motor vehicle. Nothing herein shall
40 prevent any motor vehicle from being registered as a commercial motor vehicle if the motor vehicle
41 could otherwise be so registered;

42 (49) "Recreational off-highway vehicle", any motorized vehicle manufactured and used
43 exclusively for off-highway use which is more than fifty inches but no more than sixty-seven inches
44 in width, with an unladen dry weight of two thousand pounds or less, traveling on four or more
45 nonhighway tires and which may have access to ATV trails;

46 (50) "Recreational trailer", any trailer designed, constructed, or substantially modified so that
47 it may be used and is used for the purpose of temporary housing quarters, including therein sleeping
48 or eating facilities, which can be temporarily attached to a motor vehicle or attached to a unit which
49 is securely attached to a motor vehicle;

1 (51) "Rollback or car carrier", any vehicle specifically designed to transport wrecked,
 2 disabled or otherwise inoperable vehicles, when the transportation is directly connected to a wrecker
 3 or towing service;

4 ~~[(51)]~~ (52) "Saddlemount combination", a combination of vehicles in which a truck or truck
 5 tractor tows one or more trucks or truck tractors, each connected by a saddle to the frame or fifth
 6 wheel of the vehicle in front of it. The "saddle" is a mechanism that connects the front axle of the
 7 towed vehicle to the frame or fifth wheel of the vehicle in front and functions like a fifth wheel
 8 kingpin connection. When two vehicles are towed in this manner the combination is called a
 9 "double saddlemount combination". When three vehicles are towed in this manner, the combination
 10 is called a "triple saddlemount combination";

11 ~~[(52)]~~ (53) "Salvage dealer and dismantler", a business that dismantles used motor vehicles
 12 for the sale of the parts thereof, and buys and sells used motor vehicle parts and accessories;

13 ~~[(53)]~~ (54) "Salvage vehicle", a motor vehicle, semitrailer, or house trailer which:

14 (a) Was damaged during a year that is no more than six years after the manufacturer's model
 15 year designation for such vehicle to the extent that the total cost of repairs to rebuild or reconstruct
 16 the vehicle to its condition immediately before it was damaged for legal operation on the roads or
 17 highways exceeds eighty percent of the fair market value of the vehicle immediately preceding the
 18 time it was damaged;

19 (b) By reason of condition or circumstance, has been declared salvage, either by its owner,
 20 or by a person, firm, corporation, or other legal entity exercising the right of security interest in it;

21 (c) Has been declared salvage by an insurance company as a result of settlement of a claim;

22 (d) Ownership of which is evidenced by a salvage title; or

23 (e) Is abandoned property which is titled pursuant to section 304.155 or section 304.157 and
 24 designated with the words "salvage/abandoned property". The total cost of repairs to rebuild or
 25 reconstruct the vehicle shall not include the cost of repairing, replacing, or reinstalling inflatable
 26 safety restraints, tires, sound systems, or damage as a result of hail, or any sales tax on parts or
 27 materials to rebuild or reconstruct the vehicle. For purposes of this definition, "fair market value"
 28 means the retail value of a motor vehicle as:

29 a. Set forth in a current edition of any nationally recognized compilation of retail values,
 30 including automated databases, or from publications commonly used by the automotive and
 31 insurance industries to establish the values of motor vehicles;

32 b. Determined pursuant to a market survey of comparable vehicles with regard to condition
 33 and equipment; and

34 c. Determined by an insurance company using any other procedure recognized by the
 35 insurance industry, including market surveys, that is applied by the company in a uniform manner;

36 ~~[(54)]~~ (55) "School bus", any motor vehicle used solely to transport students to or from
 37 school or to transport students to or from any place for educational purposes;

38 ~~[(55)]~~ (56) "Scrap processor", a business that, through the use of fixed or mobile equipment,
 39 flattens, crushes, or otherwise accepts motor vehicles and vehicle parts for processing or
 40 transportation to a shredder or scrap metal operator for recycling;

41 ~~[(56)]~~ (57) "Shuttle bus", a motor vehicle used or maintained by any person, firm, or
 42 corporation as an incidental service to transport patrons or customers of the regular business of such
 43 person, firm, or corporation to and from the place of business of the person, firm, or corporation
 44 providing the service at no fee or charge. Shuttle buses shall not be registered as buses or as
 45 commercial motor vehicles;

46 ~~[(57)]~~ (58) "Special mobile equipment", every self-propelled vehicle not designed or used
 47 primarily for the transportation of persons or property and incidentally operated or moved over the
 48 highways, including farm equipment, implements of husbandry, road construction or maintenance
 49 machinery, ditch-digging apparatus, stone crushers, air compressors, power shovels, cranes, graders,

1 rollers, well-drillers and wood-sawing equipment used for hire, asphalt spreaders, bituminous
 2 mixers, bucket loaders, ditchers, leveling graders, finished machines, motor graders, road rollers,
 3 scarifiers, earth-moving carryalls, scrapers, drag lines, concrete pump trucks, rock-drilling and
 4 earth-moving equipment. This enumeration shall be deemed partial and shall not operate to exclude
 5 other such vehicles which are within the general terms of this section;

6 ~~[(58)]~~ (59) "Specially constructed motor vehicle", a motor vehicle which shall not have been
 7 originally constructed under a distinctive name, make, model or type by a manufacturer of motor
 8 vehicles. The term specially constructed motor vehicle includes kit vehicles;

9 ~~[(59)]~~ (60) "Stinger-steered combination", a truck tractor-semitrailer wherein the fifth wheel
 10 is located on a drop frame located behind and below the rearmost axle of the power unit;

11 ~~[(60)]~~ (61) "Tandem axle", a group of two or more axles, arranged one behind another, the
 12 distance between the extremes of which is more than forty inches and not more than ninety-six
 13 inches apart;

14 ~~[(61)]~~ (62) "Towaway trailer transporter combination", a combination of vehicles consisting
 15 of a trailer transporter towing unit and two trailers or semitrailers, with a total weight that does not
 16 exceed twenty-six thousand pounds; and in which the trailers or semitrailers carry no property and
 17 constitute inventory property of a manufacturer, distributor, or dealer of such trailers or semitrailers;

18 ~~[(62)]~~ (63) "Tractor", "truck tractor" or "truck-tractor", a self-propelled motor vehicle
 19 designed for drawing other vehicles, but not for the carriage of any load when operating
 20 independently. When attached to a semitrailer, it supports a part of the weight thereof;

21 ~~[(63)]~~ (64) "Trailer", any vehicle without motive power designed for carrying property or
 22 passengers on its own structure and for being drawn by a self-propelled vehicle, except those
 23 running exclusively on tracks, including a semitrailer or vehicle of the trailer type so designed and
 24 used in conjunction with a self-propelled vehicle that a considerable part of its own weight rests
 25 upon and is carried by the towing vehicle. The term trailer shall not include cotton trailers as
 26 defined in this section and shall not include manufactured homes as defined in section 700.010;

27 ~~[(64)]~~ (65) "Trailer transporter towing unit", a power unit that is not used to carry property
 28 when operating in a towaway trailer transporter combination;

29 ~~[(65)]~~ (66) "Truck", a motor vehicle designed, used, or maintained for the transportation of
 30 property;

31 ~~[(66)]~~ (67) "Truck-tractor semitrailer-semitrailer", a combination vehicle in which the two
 32 trailing units are connected with a B-train assembly which is a rigid frame extension attached to the
 33 rear frame of a first semitrailer which allows for a fifth-wheel connection point for the second
 34 semitrailer and has one less articulation point than the conventional A-dolly connected truck-tractor
 35 semitrailer-trailer combination;

36 ~~[(67)]~~ (68) "Truck-trailer boat transporter combination", a boat transporter combination
 37 consisting of a straight truck towing a trailer using typically a ball and socket connection with the
 38 trailer axle located substantially at the trailer center of gravity rather than the rear of the trailer but
 39 so as to maintain a downward force on the trailer tongue;

40 ~~[(68)]~~ (69) "Used parts dealer", a business that buys and sells used motor vehicle parts or
 41 accessories, but not including a business that sells only new, remanufactured or rebuilt parts.
 42 Business does not include isolated sales at a swap meet of less than three days;

43 ~~[(69)]~~ (70) "Utility vehicle", any motorized vehicle manufactured and used exclusively for
 44 off-highway use which is more than fifty inches but no more than sixty-seven inches in width, with
 45 an unladen dry weight of two thousand pounds or less, traveling on four or six wheels, to be used
 46 primarily for landscaping, lawn care, or maintenance purposes;

47 ~~[(70)]~~ (71) "Vanpool", any van or other motor vehicle used or maintained by any person,
 48 group, firm, corporation, association, city, county or state agency, or any member thereof, for the
 49 transportation of not less than eight nor more than forty-eight employees, per motor vehicle, to and

1 from their place of employment; however, a vanpool shall not be included in the definition of the
 2 term bus or commercial motor vehicle as defined in this section, nor shall a vanpool driver be
 3 deemed a chauffeur as that term is defined by section 303.020; nor shall use of a vanpool vehicle for
 4 ride-sharing arrangements, recreational, personal, or maintenance uses constitute an unlicensed use
 5 of the motor vehicle, unless used for monetary profit other than for use in a ride-sharing
 6 arrangement;

7 ~~[(71)]~~ (72) "Vehicle", any mechanical device on wheels, designed primarily for use, or used,
 8 on highways, except motorized bicycles, vehicles propelled or drawn by horses or human power, or
 9 vehicles used exclusively on fixed rails or tracks, or cotton trailers or motorized wheelchairs
 10 operated by handicapped persons;

11 ~~[(72)]~~ (73) "Wrecker" or "tow truck", any emergency commercial vehicle equipped,
 12 designed and used to assist or render aid and transport or tow disabled or wrecked vehicles from a
 13 highway, road, street or highway rights-of-way to a point of storage or repair, including towing a
 14 replacement vehicle to replace a disabled or wrecked vehicle;

15 ~~[(73)]~~ (74) "Wrecker or towing service", the act of transporting, towing or recovering with a
 16 wrecker, tow truck, rollback or car carrier any vehicle not owned by the operator of the wrecker, tow
 17 truck, rollback or car carrier for which the operator directly or indirectly receives compensation or
 18 other personal gain.

19 301.067. 1. For each trailer or semitrailer there shall be paid an annual fee of seven dollars
 20 fifty cents, and in addition thereto such permit fee authorized by law against trailers used in
 21 combination with tractors operated under the supervision of the highways and transportation
 22 commission of the department of transportation. The fees for tractors used in any combination with
 23 trailers or semitrailers or both trailers and semitrailers (other than on passenger-carrying trailers or
 24 semitrailers) shall be computed on the total gross weight of the vehicles in the combination with
 25 load.

26 2. Any trailer or semitrailer may at the option of the registrant be registered for a period of
 27 three years upon payment of a registration fee of twenty-two dollars and fifty cents.

28 3. Any trailer as defined in section 301.010 or semitrailer may, at the option of the
 29 registrant, be registered permanently upon the payment of a registration fee of fifty-two dollars and
 30 fifty cents. The permanent plate and registration fee is vehicle specific. The plate and the
 31 registration fee paid is nontransferable and nonrefundable, except those covered under the
 32 provisions of section 301.442.

33 4. Beginning August 28, 2019, the annual registration fees imposed under this section or
 34 section 301.030 for recreational trailers, as defined under section 301.010, shall be payable in the
 35 month of May each year. Any fee that would have been due in December 2019, shall be deferred
 36 until May 2020."; and
