FISCAL ANALYSIS

ASSUMPTION

§§571.030 and 571.517 - Transport and storage of firearms in motor vehicles

Officials from the **Office of Administration (OA)** state the regulation regarding weapons on state property (Public Use of State Facilities, 1 CSR 35-1.050(5)) provides that firearms can be stored in a vehicle on state property if the person has a concealed weapons permit. This bill allows any individual who "lawfully possesses" a firearm to store it in a locked vehicle. Therefore, this bill will require the OA/Division of Facilities Management, Design and Construction (FMDC) to revise the regulation. FMDC did not provide a cost to revise the regulation, as the cost would be minimal.

Additionally, this bill provides an exception for parking lots where access is controlled in one of the specified manners, if a place for temporary storage of unloaded firearms or an alternative parking area reasonably close to other parking is provided. FMDC did not analyze the cost of these alternatives, as FMDC assumes they would not be feasible at most state facilities.

Oversight assumes the OA/FMDC will be able to revise the regulation related to this proposal with existing resources.

Oversight notes that the Attorney General's Office, Department of Corrections, Department of Public Safety (Capitol Police and Missouri State Highway Patrol), Office of Prosecution Services, Office of State Courts Administrator and State Public Defender's Office have stated the proposal would not have a direct fiscal impact on their organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.
