FISCAL ANALYSIS

ASSUMPTION

Establish Internet and Social Media Awareness Program

Officials from **Department of Elementary and Secondary Education (DESE)** assume it would take between 90-240 hours to develop one hour of training. The costs are based on an average hourly labor cost of \$65/hour. That would be somewhere between \$5,850 and \$15,600 for one hour of content or an average of \$10,725 per finished hour. In this case, the cost would be \$21,450 for a two-hour e-learning training. The total cost among the three grade levels would be \$64,350 (\$21,450 x 3).

Oversight assumes there could be a one time cost of \$64,350 based on DESE's estimate to develop a two-hour e-learning training for three grade levels, if appropriated by the State.

Course Materials and Instruction

Officials from **Sherwood-Cass R-VIII School District** state, depending on the district and the size of the school, this would require districts to hire additional staff to teach specific secondary courses and possibly at the elementary level. For our district that would cost us about \$45,000 to \$55,000. This would erase any increase to the State Adequacy Target (SAT) we receive from one year to the next from the state and could hinder other opportunities to spend those funds towards other student courses.

Officials from the **Wellsville-Middletown R-1 School District** assume this proposal will have a negative fiscal impact on the district in that it will require the district to divert time and already strained resources from other instructional activities and much of what is covered in this proposal is already a component of other classes.

Officials from the **Springfield Public Schools** assume this proposal will cost \$50,000 in course development and materials.

Officials from the **Lee's Summit R-7 School District** assume this proposal will have no fiscal impact as the district utilizes an academy approach for students K-6 and best practices for digital citizenship at the secondary level. All students also agree to an acceptable use policy as well.

Officials from the **Kirksville R-III School District** assume the proposal will have no fiscal impact on their organization.

ASSUMPTION (continued)

Oversight notes some school districts indicated costs for course development, materials and teaching staff to implement this proposal. Oversight will show a cost to school districts that could exceed \$100,000.

Promulgate Rules

Officials from the **Joint Committee on Administrative Rules** assume this proposal is not anticipated to cause a fiscal impact beyond its current resources.

Oversight assumes JCAR will be able to administer any rules resulting from this proposal with existing resources.

Officials from the **Office of the Secretary of State (SOS)** assume many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$5,000. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with the core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

Oversight assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could require additional resources.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

This bill establishes the "Internet and Social Media Awareness Program" to increase awareness of appropriate online behavior and skills among students in public schools. In coordination with the Career and Technical Education Advisory Council, materials will be developed and evaluated by the Department of Elementary and Secondary Education.

Beginning in school year 2020-2021, each public school shall provide instruction in 4th grade, a required course in 8th grade, and an elective course in high school on how to navigate online courses and appropriate online behavior.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
