ASSUMPTION

§559.600 - Private probation supervision

Oversight notes that the **Department of Corrections** and **Office of State Courts Administrator** have stated the proposal would not have a direct fiscal impact on their organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Oversight has contacted the Department of Corrections (DOC) and Office of State Courts Administrator (OSCA) to obtain a listing and/or the number of private probation services in addition to the number of offenders utilizing the service.

Officials from the OSCA are not able to reliably provide a list of court-approved entities that provide private probation supervision services. Circuit courts are responsible for contracting with the companies that provide this type of service. Courts enter the probation record but can not tell if a private probation supervision services company is being used by an offender.

FISCAL IMPACT - Small Business

This proposal could have a fiscal impact on small businesses which are private probation supervisors.

FISCAL DESCRIPTION

This bill prohibits a person sentenced to serve probation with a private entity providing probation services from being required to submit to drug or alcohol testing unless the person is on probation as a result of a drug or alcohol related offense.

Additionally, the bill requires private probation service entities to award earned compliance credits to clients for every month of compliance with the terms of probation. Earned compliance credits shall reduce the term of probation by 30 days for each full calendar month of compliance with the terms of supervision, and the requirements and procedures for such earned compliance credit shall be the same as the requirements and procedures for the Department of Corrections. Credits shall begin to accrue for eligible offenders after the first full month of supervision or, if the offender began a term of probation before September 1, 2019, on October 1, 2019.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
