FISCAL ANALYSIS

ASSUMPTION

Officials at the **St. Louis County Police Department** assume that since the Sheriff's Department generally serves the orders of protection and the Department serves emergency orders of protection, there is a potential for increased operational costs to obtain and serve emergency orders. Estimating the cost would be difficult but the increase is not anticipated to be significant.

Officials at the **Joplin Police Department** assume there would be no fiscal impact on the agency however, there may be some on the Sheriff's Office since they are the ones that issue protection orders.

Oversight assumes there could be additional costs to counties from serving additional protection orders to victims of crime. Oversight has no statistics on how many protection orders are served each year in each county but does believe the additional duties could be accomplished with existing personnel. Therefore, Oversight will reflect a \$0 direct fiscal impact for this proposal.

Officials at the Office of the State Courts Administrator, the Department of Corrections, the Department of Social Services, the Missouri Highway Patrol, the Office of Prosecution Services and the Office of the State Public Defender each assume no fiscal impact to their respective agencies from this proposal.

Oversight notes that the Office of the State Courts Administrator, the Department of Corrections, the Department of Social Services, the Missouri Highway Patrol, the Office of Prosecution Services and the Office of the State Public Defender have stated the proposal would not have a direct fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Officials at the **Boone County Sheriff Department** and the **Jackson County Sheriff's Office** each assume no fiscal impact to their respective entities from this proposal.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other local law enforcement agencies were requested to respond to this proposed legislation but did not.
